EOC Restructure Update from 2013 Query:

VIHRC members had requested clarification based on resolution passed at 2012 PSAC National Triennial Convention. Virginia Vaillancourt sent up request to obtain clarification for committee.

Response received:

From the outset, please be assured that women have been, and continue to be, a stand-alone equality-seeking group. To be sure, important gains have certainly been made. However, full equality for women remains elusive.

The PSAC undertook an independent review of the effectiveness and structure of the Equal Opportunities Committee (EOC) in 2008. The review recommended that women be included in the PSAC national equity committee in order to ensure that there was a specific gender perspective on the committee. As a result of the review, the NBoD restructured and renamed the EOC to include Regional Council Representatives for Women on the newly constituted National Human Rights Committee. Thus, there is now a Women's working group on the NHRC, and women are now specifically represented. The Women's Working Group, is tasked with reviewing and working on women's issues and priorities in the Union. The Working Group also works in collaboration with the seven regional representatives of each of the following equity groups: racially visible, Aboriginal, persons with a disability and GLBT members.

The PSAC Constitution recognizes the specificity of women as distinct from the other equity groups. It is still important to provide women-only space for women to discuss and take leadership on their specific issues. To that end, Regional Women's Committees remain constitutionally recognized distinct bodies that exist outside and separate from the Regional Human Rights Committees.

Similarly, the National Women's Conference remains a women's only event. While it is true that the last Women's Conference was held simultaneously with the other four



equity conferences, the workshops, elections and resolutions debate all remained women only space. Finally, a quick note to advise that, pursuant to a resolution adopted at the 2012 Triennial Convention, two delegates were elected at the National Women's Conference to attend the next Convention.

VIHRC Delegate Stipend:

Motion: Virginia Vaillancourt made a motion for VIHRC to cover the \$200.00

registration fee to the 6th PSAC BC Triennial Convention.

Request by VIHRC delegate Paul Jones to have committee cover a stipend to cover some of the loss of wages for Friday April 25th. Paul Jones advised committee that he had talked to his Local about assistance and was advised that UNDE was only covering costs for those representing UNDE directly.

Motion: Virginia Vaillancourt made a motion for VIHRC to cover a stipend of

\$150.00 for Friday April 25th for VIHRCs delegate.

Paul Jones advised that he would do the registration for the committee again for PRIDE Parade and a table at the Festival and will consult with REVP BC's assistant regarding funding for fees.
