Drafted Budget 2013-2014 was presented and revised.

M/S Jennifer/Heather to accept the drafted budget. Few changes were made regarding the use of some words: instead of deficit it was suggested to use the words "over-expenses".

Angela suggested that membership fees stated in the drafted budget be increased from \$300 to \$600 and the social funds be reduced from \$500 to \$200. M/S Jeremy/Rina to accept the motion - carried.

It was also discussed that the WFVAC fund its members to attend BC Equity conference in mi-November in Vancouver as well as the Regional convention.
