### **Business Arising:**

May Day – May 1, VDLC supported event. Starting at the Maritime Labour Centre this year, marching to Grandview Park. Great event that attracts Unions, Anarchists, International Workers Union. We would like to see members come out to this event. Starts at 5PM.

June NPSW – the Softball Tournament

In the past few years it has brought together 100-200 members from various PSAC components. We won't be able to hold it during NPSW this year, logistically doesn't work, as PSAC BC Convention is on the weekend following NPSW. Thinking we could move it to the summer, maybe combine with the Area Council BBQ and hold on a Friday in July or August.

Canada Day – might be a good idea to find an event for the Area Council to participate in for the 150<sup>th</sup> Birthday of Canada, consider having an information booth if the City of Vancouver has a large event.

Bargaining – most bargaining is complete, Parks and Customs and Agriculture are still at the table.

Pride – traditionally the Area Council participates in this event that takes place on the August long weekend. Fun event to walk in or staff the table.

Labour Day – September, BC Fed supported, been having some larger bands the past few years.

Summer BBQ – July or August, maybe tie to the Baseball Tournament

Vaisaki – Kelly Sidhu had a table there, very short notice so didn't have a lot of materials there, but a good place to consider for next year

Khatsalano Days – August, Marion will look into it some more

Folk Festival – do we still want to try to do this, the members who volunteered to look into this are not in attendance, will need to connect with them to find out more info

Bob Jackson asked about Car Free days, but they fall on the weekend of Convention this year, so maybe not this year, but keep it on the radar for other years.

Jamey thanked Bob for all the support he has provided over his 2 terms as REVP, this will be the Area Council's last meeting before Bob retires in June. Jamey turned the chair over to Bob to speak.

### Bob Jackson:

It has been challenging to get people out to Area Council meetings across the region, really glad to see new faces at this meeting. This council represents 1000s of members.

Ratification – Collective Bargaining has been a long process, as I'm sure the UTE members are aware, we always try to improve the process, we come prepared to bargain, but end up being stalled by the Treasury Board. We need to concentrate on talking to our MPs about the process and the issues at hand, make bargaining a priority for them as well. We need to meet with our MPs about the issues, right now Phoenix and Collective Bargaining.

We don't take advantage of meeting MPs nearly enough, it is a Constitutional Right that we need to use more often. We need to hold our elected officials accountable. Area Councils need to renew their commitment to meet with MPs.

Our negotiations didn't produce as much as they could have, not much in the way of monetary gains, but we did make gains in Work Force Adjustment and were able to protect Sick Leave.

All locals should have a Standing Committee on Collective Bargaining, it should be ongoing, rather than waiting for the call out for bargaining demands. This committee and all Locals should know the deficiencies and grievances on articles, it should be an ongoing process.

The grassroots need to be a part of the process.

The Ratification Votes produced the expected results, now it's up to the Treasury Board to set the meeting to sign the Collective Agreements. The provisions and retroactivity take effect once the agreements are signed.

The Re-Opener clause will kick in for the UTE agreement with the monetary gains that will take effect in the Treasury Board agreements once they are ratified.

The AEC will have a debrief on the process as well as within the region. Some of the feedback was that there needs to be a review of the Voting Process that is laid out in Regulation 15. We are going in the direction of Electronic Voting, a process that was piloted through the CFIA ratification in the last round. The realization is that it will be harder to implement with Treasury Board ratification, have to work out the process for multiple employer tables.

#### BC Election – still Bob Jackson

There are 2 PSAC candidates running for the BC NDP, Bowinn Ma and Janet Routledge. Janet participated in the recent Telephone Town Hall held by PSAC BC and found it a very effective way to reach out. Sargy Chima is running in Surrey/Whalley for the BC Liberals, Bob wished her well in her

campaign, but had to let her know that the PSAC/House of Labour would not be supporting her campaign because of the party she is running with.

The BC Liberals have weakened the position of working people in this province. It is time for a change, a new era for working people in BC.

Bob thanked the Area Council for allowing him to sit in with us and asked for questions from the floor. Seeing none, he turned the chair back over to Jamey.

Jamey followed up with his own comments on some of Bob's speaking points.

On Electronic Voting – it is easy, yes, but having members come into a meeting allows the bargaining team to meet with members and get fence-sitters to make a choice based on the information that can be provided at a meeting and the interaction and opportunities to answer questions.

On the Provincial Election – the Telephone Town Hall was very successful, had seven hundred to 1000 members on at certain points of the call. The MVA Provincial Accountability Assembly was also a successful exposure to the issues of this election. Christy Clark didn't come out for this event, but the other leaders, John Horgan and Andrew Weaver did. John Horgan made a clear commitment to working with the MVA on all of the issues that were introduced. Andrew Weaver didn't fully commit to work on the issues with the MVA, but did not say he wouldn't work with them either. Approximately 800 people attended the Assembly representing religious organizations, labour and community groups. On a personal note, Jamey actually had members of his own local come to him after who were there with different group affiliations, ie not there representing their union, but other affiliations.

The ridings the Bowinn and Janet are running in are considered "battleground" ridings, they were very close last election, could be taken by these candidates, please consider helping out on their campaigns, volunteering. The PSAC has committed funding to both of their campaigns.

They are looking for volunteers for E-day, May 9th.

The most important thing that any of us can do is get out and VOTE. Talk to your friends, family, coworkers about the importance of voting, of participating in democracy.

There is an opportunity with this election to make a significant change in this province.

Sky shared that she has been on a few round table discussions with John Horgan, but also been on the news. She was approached by her Director at work about the possibility of her participation in this way being in violation of the Conflict of Interest Agreement. Make sure you know your political rights. You can't speak representing your employer, but you are allowed to participate in the political process. You are allowed to personally be in favor of any party. As a counter to this meeting with her director, Sky, as part of her local executive, sent out information about our Political Rights.

Bob advised that Sky should go further up the Union chain to let her leaders know that she had experienced this from her director.

Monica reminded the members that Advance Voting starts on the weekend following the meeting.

Jamey then spoke to the Resolutions to Convention that the Area Council submitted. They were received in good order, except the 2<sup>nd</sup> be it resolved of the Racially Visible Leadership Education resolution, which was ruled out of order by the National President because it directed the disposition of staff.

# **Affiliate Reports**

UPCE 20095 – The Teamsters very nearly went on Strike at Purolator at the beginning of April, a last minute return to the table averted strike action, which would have negatively impacted the UPCE members at Purolator, there would have been no work if there was no one to move the packages. UPCE 20095 would like to thank Bob Jackson for his generous support during this trying time, especially for offering to go to the main job site in Richmond had strike action gone forward. The cutting of hours and attacks on full-time positions continues, making working at Purolator more and more precarious. Another store will be closing in June.

No other written reports were received.

Out of the Affiliate reports, came a discussion of possibly holding a Phoenix protest, maybe set up a meeting at an MPs office so that we know the MP is there, then hold a protest with members showing up at the MPs office. Also, out of affiliate reports, Bob let the membership know that any Phoenix issues should be reported to the REVPs office and nationally to your Component, especially if the issues are not being resolved. Keep records of issues, check your pay every pay period and keep on top of it.

Bob Jackson had to leave at 6:35 PM.
