# REPORT OF THE REGIONAL EXECUTIVE VICE-PRESIDENT TO THE B.C. REGIONAL COUNCIL November 2012 through March 2013

### **Political Action**

### "We Are All Affected" Campaign

It's been nearly a year since the "We Are All Affected" (WAAA) campaign was launched by the PSAC as a mobilizing tool to show our collective support for those members and their families who have received affected letters. At the same time, this campaign has also enabled us to voice the value of federal public services provided by our members and the negative impact that Harper's budget cuts have had on all Canadians.

In late 2012, the AEC committed to continuing this campaign until the next federal election; however, the WAAA campaign has taken a new focus in recent months. The new focus of the campaign centres around the latest attempt by the Federal Government to conduct a conservative and corporate assault on unions and the democratic rights of workers and citizens: we have heard that the Harper Government is taking steps to introduce legislation that will outlaw the requirement that all bargaining unit members contribute to the cost of union representation through mandatory dues, formally known as the RAND Formula.

With the experience gained from Bill C-377 (introduced as a private member's bill in 2012, and currently in the Senate seeking approval), we know that backroom lobbying alone will not stave off this most recent threat to the RAND Formula and Canadian unions. Therefore the PSAC, with its allies, plans to fend off this attack through a strategic national action plan. We plan to work with our affiliates and allies to wage a strong, visible defense of worker and union security.

To begin, we are organizing a rigorous and systematic membership education initiative over the next couple months to explain to every PSAC member this renewed threat to the union and worker security and the risk to the democratic functioning of our union. To do so, each Region has organized meetings for representatives from every Local so that we can speak directly to members about the value of our union and the importance of our right to advance the interests of our members and workers in the workplace, the community and in the public and political arenas.

With the support of all Components, these meetings will equip local and workplace leaders to engage in one-on-one conversations with PSAC members within their areas about the threat to unions and its implications. In BC, we have scheduled three meetings:

• April 19 in Kelowna – encompassing Locals and members from the Southern Interior

- April 22 in Victoria encompassing Locals and members from Vancouver Island
- April 26 in Surrey encompassing Locals and members from the Lower Mainland, Fraser Valley and Northern BC

Our expectation is that every Local will be represented at one of the meetings. In addition, we anticipate the full participation of National Officers within the Region and the B.C. Regional Council. Together we will be able to rally and unite to show the Harper Government that we will not tolerate any attempt to legislate away our negotiated and legal rights.

I must emphasize that this assault on the RAND Formula is an unprecedented attack on workers and their unions in Canada. Taking the RAND Formula away is fundamentally undemocratic and undermines Canadian principles and values. For these reasons, it is now more important than ever to continue the work of the WAAA campaign and vocalize our opposition against the Harper Government its latest attempt to weaken not just unions but the rights and working conditions of all Canadians.

### **Kitsilano Coast Guard Station**

Despite our best efforts with the BC Federation of Labour, UCTE, the public and other community groups, the Kitsilano Coast Guard Station officially closed in February on the same day that the BC Provincial budget was delivered. This timing of the closure was a cowardly attempt by the Federal Government to close the doors of the station while the media was otherwise occupied.

In advance of the closure, there was fantastic support for our bid to keep the Kits Coast Guard open from the opposition, provincial and municipal levels of government, as well as many concerned citizens. This support culminated in a large rally at the Jericho Sailing Centre on January 19, which even included participation by the likes of John Cummings of the BC Conservative Party.

While our fight is far from over, I would like to acknowledge the unwavering hard ward of UCTE, and in particular Dave Clark, the National Officer responsible for the Region as well as the dedicated efforts of Jim Sinclair of the BC Federation of Labour. Together we will continue to put pressure on the Harper Government regarding this reckless decision to close the station and put countless lives at risk.

#### **CLC Political Action Conference**

At the end of March, Patrick Bragg and I will be attending the CLC Political Action Conference in Toronto along with our counter-parts from the other regions. The aim of this conference

is to "serve as a launching pad for a focused motivational campaign to elevate and advance labour's issues as vote determining issues, as well as building the next generation of successful union campaigns." The conference will include hands-on workshops and will expose activists to the latest modern tools, tactics, and strategies for effective campaigning.

Also attending are two full-funded members from BC as well as a fully-funded Young Worker from our Region. The AEC decided to fund these three attendees in an effort to encourage participation by a wide number of PSAC members at this important conference.

Once the conference is concluded, I'm confident that all the conference attendees will have skills and tools necessary to continue the fight against the Harper Government and the allies available to help them in their efforts.

### Visibility in the workplace and community

While much of the past few months has been spent traveling back and forth between the Vancouver REVP Office and meetings at the PSAC Headquarters, I was able to include a brief trip to Prince George in early March for some worksite visits. Also included in that trip's itinerary was the North Central Labour Council's IWD breakfast. The breakfast was widely attended by many within the Labour Community and including several PSAC members. I was pleased to attend this IWD event and reflect on the progress that has been made for women.

Following the IWD event, I had the opportunity to attend the Prince George RWC's AGM. I'd like to thank the Committee for extending the invitation to me to attend. I am always eager to hear from Regional Committees on their priorities and plans for further member engagements. I also value these meetings in that they allow me to better understand regional issues and/or matters pertaining to specific member groups within the PSAC.

I also used the opportunity to visit CIU and UCTE members at the Prince George Airport, UTE, USGE, Agriculture, and UEW members in their workplaces. These visits provide me with valuable information on what members are experiencing in the field and the impacts of the Government's assault on services our membes provide.

My hope is that visits such as this March trip provide members with an opportunity to talk about workplace issues as well as regional and national PSAC concerns with me. With this information, I can voice their comments with the National Office on their behalf.

### **BC Provincial Election**

With only a couple months left until BC voters head to the polls, candidates are gearing up and busy organizing their campaigns. In the case of BC NDP candidates, their campaigns are

proceeding with the support of many in the labour community affiliates, which also includes PSAC members.

Initially, the Region presented an ambitious action plan around the provincial election, but subsequently had to scale it back in light of the threat of the attack on the Rand Formula by the Federal Government and the renewed *WAAA* campaign. Nevertheless, in the Region we are still proceeding with a plan to provide support to the BC NDP through Regional mail-outs from the REVP Office. The mail-outs, which will go to every PSAC member in the province, will identify the importance for voting for a progressive party that defends the rights of working people. In addition, we have asked the Region's Area Councils to play an active role in the campaign, supporting candidates within the constituencies either financially or in terms of volunteer hours.

To that end, I would encourage every member to support the BC NDP campaign in any way that they can, including the most important activity: casting a ballot on May 14th.

# **Health and Safety**

With my AEC portfolio of Health & Safety, I have been busy planning the National Health & Safety conference, taking place this April in Montreal. Before the holidays, the NBoD National Health & Safety Conference Organizing committee met and established the Conference Steering Committee and Resolutions Committee. These committees have worked hard to create an exciting agenda and schedule for the conference, which will continue under the banner of *We Are All Affected* messaging with an emphasis on workplace mental health issues. Through the committees' efforts, the conference objectives were also set:

- To examine the current state of enforcement of health and safety legislation which deals
  with the protection of mental health in the workplace, in order to develop union-based
  strategies that will better protect workers;
- To strengthen the ability, knowledge and effectiveness of all PSAC activists on union and joint health and safety committees to better mobilize members around mental health issues in the workplace;
- To increase the involvement of health and safety activists in the We Are All Affected campaign and to join with coalitions working to defend and advance our rights; and
- To better identify harassment and bullying and discuss what makes harassment and bullying both health and safety and human rights issues and propose specific preventive measures and responses that unions can take to prevent and deal with harassment and bullying in the workplace.

Conference applications closed in January and there were an overwhelming number of received from PSAC members wishing to attend this National conference. With over 1,000 applications received for the 300 seats available and the relatively short timeframe for Components and Regions to make their delegate choices, I must acknowledge the efforts of all in meeting the selection deadline. At this point, all conference delegates and observers have been notified of their acceptance.

I, like all delegates and observers attending, am looking forward to this conference. It will provide members attending with an opportunity to continue the important work of furthering our stance in the struggle to improve the health and safety and working conditions for all PSAC members.

### **Education**

Throughout the fall and winter, 17 courses were offered. In addition to the Region's education offerings, Leadership Training took place nationally in late November. Already the PSAC staff are looking at ways to incorporate the training delivered in Ottawa in other areas of our education program.

In addition, applications are already being accepted for the Advanced Union School, which is scheduled to take place this June in Richmond. The Union School, under the theme of "We Are All Affected and We Are All Fight Back," will offer five days of the intensive, in-residence learning for activists and leaders in the Region. I'm confident that the courses being offered will better equip our members to stand up and advocate for the rights of workers while providing an opportunity to network and converse with other PSAC activists.

### Regional

### **BC Federation of Labour Convention**

In late November the BC Federation of Labour hosted its 55th Convention in Vancouver. This Convention proved to be highly political, both with a leadership challenge and a number of resolutions addressing government attacks on provincial and federal public services that affect our members. Our Regional Political Action Committee put forward three of these resolutions including one on the Kitsilano Coast Guard Station, one on the DFO Habitat Protection Plan, and one on the Canada Grain Act.

For these reasons and more, the PSAC BC and the REVP Office strongly encouraged our members to register as delegates and attend the BC Fed Convention. As a result, the PSAC had its largest delegation ever attend. Together our delegates were able to speak on the impact of the Harper Government's cuts to an audience of over 2000 labour members.

The Convention encouraged our delegates to communicate our concerns and further secure strong allies within the greater labour movement with respect to the cuts to public services. These interactions with community partners will be integral to the next phase of the WAAA campaign our success in defeating the Harper Government in the next federal election.

### **Regional Office Open House**

To cap off the office renovations, in December we held an open house at the Vancouver RO. This provided an opportunity for members to view the improved office spaces while sharing in some seasonal cheer with staff. We were fortunate enough to have ROB Director Mark Pecek join us at the open house as his travels to the Region aligned with the date.

### **Regional Youth Committees**

On February 28th I had the privilege of attending the first ever constitutionally recognized PSAC Regional Young Workers Committee meeting in Victoria. The Vancouver Island Young Workers Committee meeting held its inaugural meeting, electing an executive and adopting terms of reference. In my address to the committee, I was pleased to acknowledge the hard work of the Committee and the fact that BC continues to lead the way on Young Workers' issues.

One week later, I attended the first official meeting of the BC Mainland Young Workers Committee in Vancouver, again witnessing our history take place as an executive was elected and priorities were set for the busy year ahead of the Committee.

As an officer of the AEC, I emphasize that it is our Union's hope that the youth within the PSAC continue to increase their involvement in union activities and take on the work before us in the years to come as we continue to fight and defeat Governments like the one currently reaking havoc in Ottawa.

### Regional Women's Conference "PSAC BC Women Hold More Than Half the Sky"

For the last several weeks, Regional staff and a small group of the Region's women activists have been hard at work organizing the upcoming PSAC BC Regional Women's conference. The conference, scheduled to take place in Richmond May 3rd-5th, aims to be a conference of empowerment for our sister activists in BC. With that in mind, look forward to the hearing about the Resolutions that will be discussed at our Region's conference, which will subsequently be forwarded on to the National Women's conference taking place later this year in November.

The Organizing Committee has selected the theme, "PSAC BC Women Hold More Than Half the Sky." Under this theme, they plan to introduce a focused look at issues affecting aboriginal women and foster a greater discussion on how to turn oppression into opportunity for

women across all sects of society and of different ethnicities. This ambitious conference has involved a lot of energy and dedication from both staff and the Organizing Committee. That said, I believe that their collective efforts will produce a very beneficial and thought-provoking session for all who attend.

We have been fortunate enough to have PSAC National President Robyn Benson arrange her schedule such that she will be able to attend a portion of this conference. I know that Robyn is anxious to come to the Region and address the PSAC BC women and acknowledge all their work on women's issues in the Region. I'm also looking forward to attending part of the conference as an Officer of the AEC and extending my support to the women of the Region and of the PSAC more generally. I am equally interested in the issues that will be discussed and the outcomes of the resolutions to be dealt with during the conference. As always, I will offer any support that I can to the Region as the REVP and to all equity groups contained within it.

### **National**

### **TC Bargaining**

As part of my AEC responsibilities, I have been assigned the responsibly for TC bargaining. As some of your will be aware, last month we communicated to the Treasury Board that the PSAC is ready to return to the bargaining table using the recommendations of the Public Interest Commission (PIC) as the basis for negotiation a tentative agreement, which were released in January by the Public Service Labour Relations Board.

After studying the report, the TC Bargaining Team confirmed that it is prepared to use the recommendations as a road map to negotiate a settlement. However, the Treasury Board sidesperson appointed to the PIC declined to sign the PIC report. Instead, that individual wrote a dissent, which disagrees with most of the recommendations of the impartial chairperson.

The legislation governing the establishment of Public Interest Commissions provides that if a PIC cannot reach a consensus on recommendations, the recommendations of the impartial chairperson shall be considered to be the report of the PIC. In response to the PSAC's proposition to return to the bargaining table, Treasury Board said that it is consulting with departments.

As we wait for Treasury Board to prepare to return to the bargaining table, the TC Bargaining Team is updating and consulting with TC members at membership and town hall meetings across the country.

### **AEC & NBoD**

As we've now entered the first year of the new national cycle, it should come as no surprise that the AEC and NBoD are busy working on many of the goals and priorities set on the convention floor almost a year ago at the National Triennial Convention. Much of this work aligns with the ongoing *WAAA* campaign and the foreseeable finish line of the 2015 federal election.

As discussed earlier in this report, much of the focus of the AEC and NBoD has been on this campaign and our preparations for our National Action Plan to defend the RAND Formula, which will also inherently defend the rights of all working people and their unions in Canada. However, also tied to the WAAA work is the PSAC's Ten Point Action Plan that was generated in November 2012 at the AEC strategy session.

The Ten Point Plan aims to reinstate our members' sense of pride in their union, a belief in the principles of trade unionism and a confidence in their elected leaders. I would like to echo our President's sentiments with regard to the Ten Point Plan: "We need to put a face to our Union, connect with our members, and find opportunities to talk to those we don't see at meetings or demos. We have to go to them, not just invite them to come to us. We need to tell them what their union has done and is doing for them." These are not easy tasks ahead of us, especially in the current political climate. Nonetheless, this is the work we have committed to and the work that we will carry out.

Much of this work can, and will, be orchestrated and initiated through the *WAAA* National Action Plan and with our Regional Meetings beginning this April. But make no mistake, the work to re-engage members will be ongoing for the AEC and NBoD even after the RAND Formula is once again consecrated in Canadian law.

As we move ahead, I'm confident that the leadership of the PSAC is poised and ready to take on this responsibility, and I look forward to contributing to this revitalization and renewal the PSAC and its membership in the Canadian labour movement.

Report to the B.C. Regional Council

Area Council - AGM was held in October where I retained my status as President. As we head into the Provincial election we intend to organize other groups such as Youth in order to host an All Candidates Meeting. The course also explained how that interaction can help when putting forward our issues and concerns so that we have extra hands coming together and helping to get our message across.

I took part in PSAC BC educational courses and met members in the Fraser Valley. Those courses included mental illness, economics, and updated grievance handling.

On January 4th, I was re-elected as my local president.

On January 16th, I was voted into an Executive position on the Fraser Valley Labour Council (FVLC) representing small locals.

On February 9th, the Fraser Valley Area Council (FVAC) met to discuss concerns and discuss upcoming events for the year including the provincial elections, Labour Day events, and political actions I was designated as Communications person have an updated list of Fraser Valley East Presidents in which I send upcoming FVAC meetings, FVLC meetings, other events that pertain to members in the Fraser Valley East area.

On February 20th and every 3rd Wednesday of the month, I will attend FVLC executive meeting, which is followed by FVLC general meeting of members. At those meetings, I give an update of what is happening in the Federal Government public services regarding the different cuts in services to British Columbians and all Canadians. Members of the FVLC want to hear and know more about this matter, and want to be able to take part in up coming campaigns.

On March 12th I attended the FVAC meeting. Bob Jackson was also in attendance and gave an update on Bill C-377 and educational courses to come up this year.

# BC Federation of Labour 55th Convention by: Patt Holmes, Regional Council and Human Rights Committee Member

I want to thank both the Vancouver Human Rights Committee and the BC PSAC Regional Council for providing me with a subsidy to attend the 55th BC Federation of Labour Convention in Vancouver from Nov. 26th to 30th, 2012. This event is memorable because I had an opportunity to network with other union participants, hear excellent, special guest speakers, gain useful and relevant information to share out and have an opportunity to speak and promote PSAC issues with a BC wide audience. If the readers of this report want details on the Convention committee reports or the Human Rights resolutions these can be found on line at the BC Federation of Labour web site.

A day prior to the Convention I attended a half day session of the "Embrace Diversity" forum along with Paul Croes and Kelly Megyesi. I got to listen to Janelle-Ho-Shing (PSAC BC) and Tamara Marshall (TWU) address "How are Unions working to press employers to ensure greater diversity in BC workplaces". I also listened to open dialogue on: (1) How do unions do a better job at reflecting the diversity of our membership? and (2) How do we achieve more equality for our members from equity seeking groups?. Unions still have a lot of work to do to on equity issues of concern.

The BC Federation of Labour Convention was energy charged with mobile teams campaigning for the Fed executive positions of President and Secretary-Treasurer. Jim Sinclair and Irene Lanzinger were re-elected in these leadership positions over Michelle Laurie and Trevor Davies. The challenge to these roles brought out some healthy debate and information on issues to the floor and at coffee and lunch.

Jim Sinclair outlined the BC Federation's vision for the province. The vision "included affordable and accessible child care and post-secondary education, the end of privatization and contracting out, restored health care funding, green jobs and safe workplaces for all." There is a lot of work to be done by unions in BC to make this vision a reality per the debate on convention floor.

I have been boasting to all that will listen that PSAC had one of their best turn outs of delegates at this convention. There were over 50 PSAC activists on the floor which were complimented by PSAC staff working at our information booths and supplying requested supports as needed to our PSAC members.

Sargy Chima, Jennifer Ho and Patt Holmes all received one of the 3 Vancouver Human Rights subsidies to be in attendance. I had done my

homework by reading all of the 11 resolutions from the Human Rights Committee to Convention and also the report of the Human Rights Committee which passed on Tuesday afternoon on the floor. Sam Wiese, a seasoned BC Federation of Labour activist advised the PSAC group of the priority of resolutions as they would come to the floor. If we wanted to speak on Human Rights it might be wise to get up and talk to our issues if they were in the human rights report. From Monday to Thursday there were no human rights issues from the committee that made it to convention floor.

### Resolutions:

i was very disappointed at the low number of resolutions that were dealt with by Convention. I did get up and speak on the BC Fed Regional Conference in the North and also on the proposed Enbridge pipeline in violation of aboriginal human rights. I lined up at the microphones to address the temporary foreign workers and the Human Rights report but the questions were called and I did not get to speak. All of the resolutions had excellent, informative and good debate. Considering it ranged from 1339 to 1972 people on the floor at any one time the fast momentum of convention was stimulating and exhausting at times. In a moment of lulls I got to speak with old friends such as Kay Sinclair, Patty Ducharme, Bob Kingston, Sharon Brine, Steve Houston and other trade unionists that I don't often get to hug and share information with.

If you are wondering what some of the resolutions were on that made it to the floor they were on: bargaining in BC; fair tax system; health care; Enbridge; forestry; temporary foreign workers and childcare to name a few. The BC Federation of Labour puts out a full report of convention on their website so keep checking their website for full disclosure of resolutions debated.

# Special Guests:

I enjoyed special guest speakers such as: Linda McQuaig; Tracey Phan; Adrian Dix; Thomas Mulcair and Ken Georgetti to name a few. Off the Convention floor both Kelly Megyesi, Regional Council Rep for Women spoke on a panel at the Monday night Women's Forum and Janelle Ho-Shing spoke on a Diversity panel for PSAC. Our PSAC speakers were clear, concise, informative and did a fabulous job of their presentations. They made me proud to be from PSAC.

# PSAC Visibility at Convention:

We did a great job. Our REVP, Bob Jackson spoke on the convention floor as did a number of other PSAC delegates. Paul Croes got his photo in colour in one of the daily convention news bulletins. Lee Provost and Sharon Brine, UNDE members were interviewed by the newspaper and mentioned in an article on downsizing of the Federal Government. We had a team of volunteers who took time to leaflet on "We Are All Affected", and the \$143 million in cuts being implemented at the Border Services and other PSAC issues. We had a PSAC information table in a special room where PSAC staff and volunteers

promoted the PSAC and our current issues. Thanks to the BC Regional Council we also had an all paid lunch where the candidates running for the BC Federation of Labour offices could come and speak to PSAC members and answer any questions we may have on issues. There was a real feeling of PSAC solidarity at the BC Federation of Labour Convention and off the floor at the rally of over 1400 delegates who marched with BC's public sector workers from the convention hall to the Vancouver Art Gallery for a "fair deal".

I got to practice at the BC Federation of Labour Convention:
"We are stronger when we stand and fight together" and "What we
desire for ourselves we also desire for others". I left convention feeling that
as union activists we would all do our part in the upcoming May 2013
Provincial election to elect a Government that will truly work on behalf
of all working people in BC for a Better BC!

In closing, "thank you" again to both the Vancouver Human Rights
Committee and Regional Council for financially assisting a union sister from
rural BC to be able to attend the 2012 Vancouver, BC Federation of Labour
Convention. I learnt a lot to share with brothers and sisters of the
North and other parts of BC. I was charged \$18.00 extra baggage fees by Air
Canada to bring Convention materials home! These documents will be shared
March 9th/13 at our International Women's Day AGM meeting and May 2013
Regional Women's Conference.

## Things That Have Taken Place Since the Last Meeting: Actions & Activities That I Have Been Involved With

After our last Regional Council meeting, I attended the Leadership Summit in Ottawa from November 30 to December 2 along with many others from the Regional Council. I then stayed on in Ottawa for the National Human Right meeting that took place from December 3 to 5, 2012.

The human rights meeting was a very interesting because it addressed the fact that, for the first time, the PSAC is going to combine five national conferences for all of the equity groups into one national conference that will take place in November 2013. The five equity groups are made up of all the regional reps and nationally elected persons. Those individuals are on the steering committee for the conference and will decide what issues are going to be covered at the conference, guest speakers and such.

The Access group, "persons with disabilities," have met 2 to 3 times since December 2012 via teleconference. Calls have lasted over one hour each time, and more calls are being booked so that the Access conference will be set up and run with information from reps in each of the regions.

Because of this, I have been asked to see if anyone that knows of any members with accommodation issues that are not being treated fairly because of WFAs or anyone with a disability that feels or has experienced issues with our employers. All regions are going to share information on what is, or what has, happened in their area or with any of their members. If you know of any situations like this, please share this information with me or contact someone with the PSAC so that this information can be documented. Thanks.

The Donations Committee is in frequent contact addressing email requests we receive from the REVP Office. We all try and are working very hard to review all requests and send in our recommendations to each other by email. I must say this has working extremely well so far.

I attended a dinner for the 20th Anniversary dinner for the Vancouver Community Network. They had a great speaker; Cindy Blackstock's speech was so well done. I felt that everyone there left the room feeling that they want to do more.

In February I attended a BRUSH meeting at the Vancouver Regional Office. As with all BRUSH meetings, I found the meeting informative.

On February 14, I was involved and joined by seven other members from the BC Mainland Human Right Committee for the annual march honouring the missing and murdered women of BC. This again is a very moving event to participate in.

In March, I attended the CCPA Annual Fundraising dinner with other PSAC members. This event was overwhelmingly attended by many in the labour community and other supporters of the CCPA. The dinner also included guest speaker Joel Bakan. At issue was the fact that the CCPA is advocating for information to be published and reviewed. If changed, this will be a good thing.

## Challenges I'm Facing:

I've been trying really hard to get things moving with the BC Mainland Human Rights Committee, but it has been difficult as I have been away often over the last few months. However, I am going to try and reach out to the active Committee members via e-mail more frequently now. I have found this communications method successful with the Donations Committee.

I am looking forward to a certain provincial political party "CRUSHING" the other political parties in the next couple months. I am also looking forward to working with all the other access reps from all over the country in the next year and beyond.

PSAC National Officers Coordinator - Nic Humphreys

Report to the BC Regional Council

A National Officers meeting was tentatively scheduled in conjunction with the spring Regional Council meeting. However, with the addition of the Area Council meetings it was felt that it would be difficult to also add a National Officers meeting so the meeting was cancelled. It is hoped that there will be an opportunity to hold a National Officers meeting in conjunction with the fall meeting of the Regional Council.

### **Provincial Election**

At the last National Officers meeting, Brother Jim Sinclair **BC Federation of Labour President** addressed the National Officers on the upcoming by-elections in Port Moody and Hope-Chilliwack, suggesting that we need to send a message to the BC Liberals through these votes, and to more specifically communicate what this vote is about. As everyone knows, we were successful in sending that message to the BC Liberals. The upcoming general provincial election is even more important to the citizens of British Columbia, and there will be communications coming forward from myself and the PSAC Regional Office detailing how the National Officers can get involved in the election to ensure the BC Liberals really get the message.

#### RAND Formula

While there seems to be an almost endless number of issues that are important to our union and our membership the latest attacked by the Harper government on the RAND formula has to be one of our most urgent. ## **Committee Reports**

PSAC BC Regional Council Environment Committee

Report to the B.C. Regional Council - March 2013

The Environment Committee has decided that "WATER" will be the priority for the committee, as it encompasses most of the environmental issues of the day and gives the committee a bit more focus. Committee discussions will ensue at the next Regional Council meeting as to whether or not include "WATER" in the terms of reference of the committee or not. The Terms of Reference have always been considered a fluid document from the inception of the committee, so any future committee could remove "WATER" if they felt it to be inappropriate or too contributing.

At the last meeting the committee put forward a document titled "Water Secretariat" (revised copy attached Appendix 1), which talks about getting a "Secretariat" formed within the provincial government that promoted the sustainable use of water in British Columbia and also how important it is to keep water public to ensure its quality and that having a sustainable water supply was advantageous to us economically. The document was also brought forward to the AEC by Bob Jackson for endorsement which was obtained (Appendix 2). The committee will continue to promote the idea of water sustainability.

#### **Rainwater Management**

As part of making water a priority the committee would like to introduce and promote the initiative of **urban water management**. A very good publication that addresses most aspects of managing urban water and on the committee would like to recommend is:

## **Disconnecting Downspouts**

An initiative that is being promoted in various cities in North America is to have urban building and households disconnect their rainwater downspouts, to divert this water into rain gardens, household gardens, and yards or into rain barrels to collect the water.

This is a simple but effective way for everyone across the province to get involved in doing something to protect British Columbia's water. Two of cities where this water diversion is being promoted and encouraged Seattle, Portland and Toronto. In Portland they actually pay you to disconnect your downspout, the water then flows out into yard and permeates down into the water table, instead of into storm drains causing flooding and beach erosion. In Toronto they have made the disconnection of downspouts mandatory:

## **Mandatory Downspout Disconnection**

## Everyone benefits from downspout disconnection

Rainwater runs off a roof, flows through the eaves troughs and discharges either onto the property (if the downspout is already disconnected) or into a downspout that carries it directly into the sewer system. During heavy rainfall, if the downspout is connected, the sewers become overloaded, increasing the risk of basement flooding and releasing polluted rainwater into our local waterways.

To help deal with the problem, the City has made downspout disconnection mandatory, city-wide. It is being introduced in three phases, beginning with the central area of the city, where storm water and sanitary drainage are combined into a single pipe.

- Combined sewer
- Separated sewer

Disconnecting your downspouts will help reduce the amount of storm water sent through the sewer system. Less storm water can help prevent wastewater from backing up and thus reduce your risk of basement flooding.



Using less water, keeping rainwater on your property and managing what and how much goes into our storm sewer system means you are protecting your home and the

environment at the same time. One way to do this is to plant a water-efficient, natural garden. For tips to get started, consult the City's <u>water-efficient landscaping</u> information.

There is a real appetite among municipalities in British Columbia to look at new ways of managing rainwater and runoff. When the disconnection of downspouts was recommended as an option to the Victoria municipal council as something that should be promoted by the city the proposal was welcomed. The city was planning to charge residents an extra tax for wastewater management, now the proposal is tax reductions if you disconnect your downspouts.

Sister Be Gomes has installed rain barrels at her house in Terrace and has the municipal council coming out to view her system as a possible initiative to promote within the city. The use of rain gardens to control, filter and clean run off water is another concept that is starting to be recognized as a solution.

## Appendix 1

### Fresh Water Secretariat

## **Summary**

That a Secretariat be formed consisting of a branch of the Premier's office; responsible for fresh water and having the ability to connect with every ministry when policy or projects touch on fresh water issues in British Columbia.

Be it drinking water, fish, agriculture or industry, fresh water will be at the heart of the Secretariat's planning and thinking. Any such initiative would of course take into account the aboriginal and treaty rights of First Nations.

The Secretariat will be a concrete manifestation of the NDP government's commitment to a sustainable BC.

The Fresh Water Secretariat will be much more than an advocacy office. It will be integral to the economy of BC and will also engage the public around the issue of a sustainable future and water management.

#### **Proposal**

- That a Fresh Water Secretariat be created as part of the NDP government structure
- That an MLA or credible senior civil servant who is willing to speak truth to power to become an expert in fresh water policy and take responsibility for the government's long term planning for BC's fresh water resources
- That the Secretariat not be cost-prohibitive & be kept small and nimble
- That the Secretariat be structured and empowered under new legislation

## There are many policy-related reasons to create the Secretariat

- 1. In the future, water will become as important as oil is today. Ten years from now decisions around access to and control of water will move the public agenda and economic policy.
- 2. The loss of the Inland Navigable Waters Act, removal of the Habitat Protection from the Fisheries Act and the gutting of the Environmental Assessment Act in service to run of river dams, pipelines etc. has much broader ramifications than just the destruction of fish habitat.

- 3. When it comes to fresh water issues, the provincial government liaises with and balances multiple interests from many different ministries the Ministries of the Environment, Agriculture, Industry, and Municipal & Community Services to name a few. The Secretariat will coordinate and connect with multiple sectors within government to ensure that policy is formed with sustainability first and foremost in mind.
- 4. The government must ensure that the use of BC's fresh water resources as an economic attractant for business take place in a sustainable and well-regulated manner. The government must also ensure that the proper regulatory frameworks and environmental assessment procedures are set up now, prior to BC's water resources becoming a highly sought after commodity.
- 5. There is a need to ensure that water remains a public resource, and to block the potential for sales of bulk water outside BC. British Columbians' access to fresh water must be protected under any future trade agreements that may be negotiated by the federal government.
- 6. Until now, water has not been defined as a commodity in Canadian or BC law. With Harper in power, there is a need to write progressive legislation regarding fresh water now. The provincial government should not wait until law or policy is dictated at a federal level but should establish precedents so that a stewardship agenda will dominate future discussions about fresh water.
