# REPORT OF THE REGIONAL EXECUTIVE VICE-PRESIDENT June 2017 to October 2017

Having been elected as the Regional Executive Vice-President for the B.C. Region this past June at the B.C. Regional Triennial Convention, this report is my first to the BC Regional Council. It has been a busy few months since the convention, and I anticipate the coming months will be equally as busy as we prepare for the PSAC leadership training, the next round of Treasury Board bargaining (already!), and the PSAC National Triennial Convention next spring. All the while, we will be equally tasked with the responsibility of holding the Liberal Government accountable with respect to the Phoenix Pay System disaster and the unfulfilled election promises they made to our members and to all Canadians.

### **Political Action and Campaigns**

### **Phoenix Pay System**

Since being elected, one of my key priorities has been the Phoenix pay system and bringing further public awareness to the struggles our members, and all federal public service workers, continue to face with each passing pay period.

On July 12, I penned an open letter to all 42 MPs in BC regarding the Phoenix pay system, calling on our MPs to stand up in the House of Commons and in their party caucus meetings and speak on behalf of their constituents who are federal government workers; I further asked that our MPs call on the Federal Government to fix Phoenix, to ensure that our members are paid correctly and on time, and to treat all federal public service workers with the respect we deserve.

The response to my letters thus far has been great. Several BC MPs of all party stripes have responded to my letter and have been in touch with the REVP Office. In a number of cases MPs have also requested meetings with me. When attending these meetings I've been intentional about bringing members with me who reside the MP's constituency because I recognize that a critical part of these MP meetings is the participation of constituents: in having the MP hear the message not only from the Union's elected officials, but from their constituents who have been affected, politicians better understand the devastating impact Phoenix has had on our members lives, on their mental health, and their ability to deliver the services Canadians need and deserve.

These meetings have also provided an opportunity to talk about other issues facing our members including Bill C-27, potential airport privatization, and collective bargaining. I hope to continue these face-to-face meetings with MPs over the course of my term to foster positive working-relationships and open dialogue between the PSAC and our elected politicians.

### **Summer Outreach Activities**

This summer the BC Region participated in a number of community events and festivals. Events included the Surrey Canada Day celebrations, the Surrey Pride Festival, the Fusion Festival, the Vancouver Pride Parade, the Saanich Fair, as well as several Labour Day events in Abbotsford, Prince George, Surrey and Victoria.

One of the motivations for continuing our public outreach is to raise public awareness and encourage continued dialogue on the Phoenix pay system disaster. Members spoke with the public about the difficulties facing our members, who don't know if they'll receive a proper pay cheque (or one at all in some cases). All the while, our members continue to provide the services the public need, deserve and expect.



By continually engaging with the public in a positive way, and reminding the community of the value of strong public services, we hope to garner support from the public on our issues – not just Phoenix, but other issues that enshrine our core principles and values as well: working against privatization and contracting out, quality public services, working to implement a living wage for all workers, retirement with respect and equitable pension plans (as opposed to what Bill C-27 proposes), respect for all persons and their innate human rights, fair collective bargaining, etc.

Iattended several of the public outreach events over the summer, including the Vancouver & District Area Council's Labour Day booth at Holland Park in Surrey. As part of their booth display, the Area Council created a "Phoenix Wheel of Misfortune" to demonstrate the unpredictable, frustrating situation members face with their paycheques and Phoenix. During the event, we were fortunate enough to have new BC Premier John Horgan stop by the PSAC booth for a conversation on Phoenix and to sign one of our 'Fix Phoenix' postcards for Scott Brison.

### Open Letter to Richmond and Victoria City Councils on Privatization

In September, I co-authored a letter with UCTE National President Dave Clark to the Mayors and City Councilors in Richmond and Victoria. The letter calls on them to join other municipal politicians in speaking out against the proposed airport sell off.

At the time of this writing, we've yet to receive a response from either municipality. However, we're hopeful that both Richmond and Victoria will recognize that if Canada's airports are sold, the airports will need bigger and bigger profits for private investors, which would be achieved by raising fees and increasing costs for tax payers.

### **Building Alliances and Supporting the Labour Community**

### Pacific Blue Cross – CUPE 1816

For two months this past summer, nearly 600 members of CUPE 1816 were locked out by their Employer, Pacific Blue Cross. This action was preceded by a lengthy labour

dispute wherein the company decided to claw back retiree benefits for current employees. The employer refused to withdraw this serious concession and would not attend the bargaining table unless the union conceded it.

To support our sisters, brothers and friends at CUPE 1816, the BC Federation of Labour and Affiliates attended a number rallies and joined them on the picket line. I attended a few of the rallies and encouraged other PSAC members to do the same. We, as PSAC members, know all too well how challenging bargaining can be with an employer determined to achieve significant concessions. After signifacant pressure from CUPE 1816 members and affiliates, in September the lock out ended and an



agreement was reached between Pacific Blue Cross and the members of CUPE 1816.

### **BC Lions: BC More Than A Bystander**

The PSAC BC Region, along with the BC Federation of Labour and many of its affiliates, had the opportunity to be part of a ground-breaking, three-year initiative between the BC Lions and the Ending Violence Association of BC. 2017 marks the second year the PSAC has been involved in this campaign.

The Be More Than A Bystander campaign aims to increase understanding around the impact of men's violence against women. As sponsors of the program, we hope to support the campaigns' efforts to break the silence surrounding violence against women and girls by providing tools, language and practical ideas about how to speak up and how to communicate that violence and abuse is not acceptable. As a thank you for our sponsorship agreement, the BC Lions have provided us with a number of tickets to upcoming games, which we have made available to members through draws.

### **Meeting with Minister of Labour**

In September, I attended a meeting with BC's new Minister of Labour, Harry Bains along with the Officers of the BC Federation of Labour. We're hopeful that this meeting is indicative of the BC NDP Government's willingness to implement policies that will improve fairness for workers, including the elimination of secret balloting and a return to the card-check system for union certification.

There are many things that can be done in BC to improve the labour code and bring back balance to the labour front. After 16 years of BC Liberal rule laws have been heavily tilted in favour of the employer. Now is the time for BC to recognize that organized labour benefits the economy. One of the major ways we can reduce the wage gap between the rich and the poor and address poverty issues is to have higher rates of unionization.

Moreover, the BC Federation of Labour and its Affiliates will continue to call for the BC NDP Government to implement a \$15/hour minimum wage, to lift welfare rates, and create a poverty reduction strategy that will ensure the needs of all British Columbians are met and that people are put before profits.

### **Regional Negotiations**

There are several units are currently in negotiations in the B.C. Region:

- Granville Island: We have achieved a tentative agreement and a ratification vote has been scheduled for October 19.
- IMP Comox: The arbitration process is moving forward. After a significant amount of pressure, the employer has finally agreed to arbitration dates in February 2018.
- First Nations Health Authority The bargaining team met with the employer in the first week of October.
- Commissionaires The Union team met with the employer the week of July 25 and is scheduled to meet with them again October 23 and 24. In July, the team was able to make some progress on language improvements regarding bereavement leave, staffing and seniority articles.
- ARINC We have applied for conciliation and expect to be meeting soon.
- North Peace Airport We have served the employer with notice to bargain, but do not have dates yet.
- Purolator A bargaining conference is scheduled for October 21 and 22 and face to face meetings with the employer will be scheduled after that.
- Prince Rupert Airport The input call for bargaining demands has gone out.
- Swissport Supervisors & Admin (YVR) The input call for bargaining demands has gone out.

### **Education**


### **Regional Education Schedule**

Over the coming weeks, the Region's fall education schedule will be rolled out across the province. In particular, we will be holding 12 separate 2-day basic weekend courses in BC this fall. Courses include: Talking Union Basics, Grievance Handling, Understanding and Interpreting the Collective Agreement, ABCs of UMCs, and Duty to Accommodate.

In addition, the fall education schedule will include a number of advanced education opportunities. In October we will be offering the Introduction to the Union for Indigenous Members (formerly known as the NAPC course).

In early January, BC will be the second Region to host Advocating and Representing Against Workplace Racial Discrimination. This is a relatively new course that was developed in the NCR, in which participants

will learn how to support racialized and indigenous members who are victims of racism and identify appropriate means of resolving workplace racial discrimination.



### **West North Union Development Program**

The 2017 West/North Union Development Program (UDP) concluded in September with Step VI taking place in Whitehorse September 21-24. At this final step of the 10-month program, participants met one last time for their mock convention. While I didn't attend the final step of the program, I received several positive reports on the participants' hard work that cames to completion. After this intensive yearlong program, all three Regions will greatly benefit from the strong new leaders who have emerged from this year's West/North UDP.

I'd like to extend my congratulations to this year's graduates; they should be very proud of their accomplishments. I'd also like to acknowledge and thank the education staff for their ongoing efforts and their tireless work to ensure the successful delivery of West/North UDP over the last year.



### Regional

### **BC Provincial Election**

It's hard to believe that British Columbians went to the polls nearly five months ago in May, and yet it was only in late July that we learned who that government will be. As many of you will know from former REVP Bob Jackson's reports, the BC election was vitally important for labour and for all working people in BC. After sixteen years of BC Liberal rule in BC, British Columbians are faced with a housing market crisis, chronically underfunded public education, insufficient seniors' care and health care services, increasing income inequality and poverty rates, not to mention the cuts to public services and increased user fees in a variety of sectors. Many of you will also know that the results of the May 9th election gave evidence that the majority of British Columbians voted for change, which was realized in June when Christy Clark's minority Liberal government fell and BC's Lieutenant Governor called on John Horgan and the BC NDP to form the next government with the support of the BC Green Party through their Confidence and Supply Agreement.

Included in the new BC NDP government are two members of the PSAC family: PSAC (and UCTE) member Bowinn Ma who ran for the BC NDP in the riding of Vancouver-Lonsdale and Janet Routledge (retired PSAC Regional Coordinator) who ran for the BC NDP in the Burnaby North riding were both successful in their elections, and we look forward to working with them, and all labour-friendly MLAs who will work hard for all working people in BC.

### **B.C. Regional Triennial Convention**

Over 180 delegates, observers, and guests gathered at the PSAC B.C. Regional Convention, which took place June 16 to 18 in Vancouver.


During the first day of Convention, delegates heard from Irene Lanzinger, President of the BC Federation of Labour, and PSAC National President Robyn Benson. They each spoke about the importance of political action and getting involved in our union. During the Convention, delegates also debated resolutions, passed the PSAC B.C. Region's budget for the next three years, and held a lunch time rally. The rally called on the government to fix the Phoenix pay system and bargain fairly with federal government workers.

The Convention also provided an opportunity to honour three BC activists with our Region's Solidarity Excellence Award. Brothers Bob Kingston and Nic Humphreys as well as Sister Alice West were recognized for their important and inspiring contributions to the PSAC.

Convention attendees also heard from two members of the PSAC family who were recently elected to the BC Legislature: Janet Routledge, BC NDP MLA for Burnaby North and Bowinn Ma, BC NDP MLA for North Vancouver - Lonsdale. Janet and Bowinn both spoke about why they decided to get involved in politics and the importance of political engagement.

Some of the resolutions passed at our Convention included: GEN-23, which calls on PSAC to educate members on the importance of a national water policy; GEN-24 which calls on PSAC to increase participation in our national Health and Safety Conference; GEN-18, which calls on PSAC to ensure members with disabilities have fuller access to the services they need to participate in PSAC events; and GEN-42, which calls on PSAC to re-activate a Charter Challenge that will fight to unionize student employees in the federal public service.

Over the course of the three days, delegates also elected their representatives to the B.C. Regional



Before the Convention concluded, members in BC and guests from Ottawa had the opportunity to pay tribute to outgoing REVP Bob Jackson, who retired after an almost four decade career as a public service worker and union activist. Brother Jackson leaves some very big shoes to fill, and BC will forever be indebted to Bob for his leadership, his advocacy for our Region and for the legacy he leaves behind. I look forward to working with the new Regional Council as we continue the great work that Bob and the former Council initiated. I am confident that the results of the 7th PSAC BC Regional Triennial Convention have put the Region is very good stead for the next three years.



This past August, I was able to attend another Component's national convention for the first time as the REVP for the hosting Region. UNDE's national convention took place in Victoria from August 21-25, and I was fortuante to attend.

As part of the Convention program, UNDE organized a rally at CFB Esquimalt to denounce the Liberal Government's privatization agenda started by the previous Conservative Government, and to bring further attention on the Phoenix Pay System fiasco. It was a great rally with excellent member participation. Media accounts of the rally noted that the crowd was "boisterous but peaceful."



### **Member Engagement**

On August 25, the Vancouver & District Area Council held their annual softball tournament and BBQ. This event has traditionally taken place during National Public Service Week as a boycott event for members to attend. However, given the dates of the PSAC Regional Convention, the Area Council opted to postpone the event until August. I attended the event along with other members of the Regional Council. This annual event provides an opportunity for members to socialize and talk to one another about the issues they're facing in the workplace. All in all, it was fun afternoon where \$500 was raised for the Metro Vancouver Alliance.

On August 30, I joined the Vancouver & District Area Council again for a Phoenix plantgate and awareness raising event they organized at Library Square in Vancouver. We had many good conversations with PSAC members and the public, and many more 'Fix Phoenix' postcards were collected.

On September 8, I joined CEIU National President Eddy Bourque and PSAC members outside the constituency office of Stephen Fuhr, MP in Kelowna for a rally. Together we called on the federal government to take the measures necessary to fix Phoenix and ensure public service workers are paid correctly and on time. The rally call, "Sunny ways? How about an employer who pays?" was heard loud and clear in Kelowna.

The rally also provided an opportunity to voice the concern that the government's decision to lay off 2,700 highly trained compensation advisors before Phoenix was rolled out was a foolish decision. It is imperative that the government rebuilds the internal expertise that was lost by eliminating these positions by hiring and training new staff, and bringing back experienced former compensation officers who are willing to do so.

I'm confident that PSAC members will continue to hold these types of events – both within the membership and with the public – over the coming months to hold the Liberal government accountable for the Phoenix Pay System debacle, for the outstanding collective bargaining, to stave off any attempts at privatization, and to remind the Liberal government of their pledge to show our members the respect they deserve.

PSAC Alternate REVP-B.C. - Todd Smith Report to the B.C. Regional Council

I'm honoured to submit my first report as Alternate REVP since our Convention in June. The last few months have been as busy as they have rewarding. I've had the opportunity to represent our membership at many events throughout the Lower Mainland and in Victoria including festivals, Canada Day, Pride events, marches, rallies, and other member-focussed events. Jamey and I met with my Member of Parliament, Don Davies, to discuss Phoenix and other issues affecting our membership such as privatization and contracting out. Additionally, I also had a number of opportunities to discuss Phoenix and other issues with Members of Parliament at public events throughout the summer.

In August, myself and others with the Vancouver and District Area Council hosted the annual softball tournament and barbecue. The event was well attended with approximately 80 participants and raised close to \$500 for the Metro Vancouver Alliance. During the event I engaged in discussion with members around Phoenix and what PSAC has been doing. We received positive feedback from attendees and got more Fix Phoenix postcards signed.

Phoenix continues to be a battle we're all fighting. I've participated in a number of successful public events where we engaged in discussion with the public about Phoenix and got hundreds of Fix Phoenix postcards signed--I even got John Horgan to sign a card for us at the Labour Day event in Surrey. The Premier mentioned that he's aware of the Phoenix fiasco and agrees that it's completely unacceptable, that it's been dragging on for this long. Earlier in the day, Federal Minister of Labour Patty Hajdu spoke to the crowd about the Liberal government being an ally and partner with labour. However, the Minister failed to acknowledge the government's own current critical labour issue: Phoenix. Jamey and I stood directly in front of Minister Hajdu wearing our Burnt by Phoenix shirts and held Fix Phoenix placards. After the Minister finished speaking we chanted, "PAY US FOR THE WORK WE DO; WE CAN'T EAT AN I.O.U." We got the attention of the crowd and received comments of support and solidarity from a number of attendees.

In September I began working with regional representatives from PIPSC and CAPE to plan a Fix Phoenix rally in downtown Vancouver on October 18th. As we began publicizing the event others across the region took note and there are now rallies planned in other areas for the same day. Noticing the level of interest for October 18th, I've scheduled a Phoenix Public Awareness Sub-Committee call open to all those in the Region who are interested in discussing political action and public awareness ideas and successes from across the Region. I'm optimistic that October 18th will be a resounding show of solidarity that will carry a loud and clear message to the government: FIX PHOENIX NOW AND RESPECT US.



Since convention I have continued my activism in regard to equity and human rights. I attended the National Aboriginal Day event at Trout Lake. In September, I marched with Sky Belt and her son to stop Kinder Morgan with hundreds of others in downtown Vancouver. With many people, groups, and organizations-including the federal governmentengaging in reconciliation it's shameful that the federal government refuses to adopt and fully implement the United Nations' Declaration on the Rights of Indigenous Peoples as called for in the Truth and Reconciliation Commission's final report. This remains a key issue with the federal government approving the Kinder Morgan pipeline when they do not have the free, prior, and informed consent of the First Nations the pipeline passes through. Not to mention we're already experiencing the effects of climate change that will only intensify if this pipeline goes through.

On October 4th I attended the Sisters in Spirit Vigil in Vancouver. It was a beautiful and moving event with impassioned speakers that touched on building solidarity within our communities, taking care of each other, empowering Indigenous women, and the challenges with voicing and championing Indigenous women's issues.

I also marched in Pride parades in Victoria and Vancouver with many members which is just as important today as it was in the days before anyone in the LGBTQ+ community was included in human rights legislation or protected in collective agreements. Many LGBTQ+ people continue to face discrimination in the workplace, community, and even at home. A member commented to me that they really value PSAC being visible at Pride events for this very reason.

Finally, I attended the Fusion Festival in Surrey alongside a number of PSAC activists at our booth where we talked to the public about the work our union does around equity and human rights in addition to raising awareness of Phoenix. The Fusion Festival is a diverse celebration of music, food, and culture.

Over the next few months I will continue my work to engage members, engage the public, and keep pressure on the government to fix Phoenix. I also look forward to working with our Area Councils around continued political action and to do some worksite visits to meet with members and learn more about the important work they do.

PSAC Geographic Coordinator for Metro Vancouver - Jennifer Horsley Report to the B.C. Regional Council - Activities Since my last report

Well, it's been a pretty busy summer since my re-election. Some of the challenges have been related to my new position at work, the same work but a different worksite. There have been difficulties around being able to schedule time off for union work due to the staffing situation and a re-organization going on at Purolator that is shaking loose a lot of member complaints and a lot of employer short-cuts in filling and deleting positions. I'm hoping that things will start to settle down before our busy season starts in December.

I've been continuing my work on the Vancouver and District Area Council, the Vancouver Regional Women's Committee, the Human Rights Committee and BRUSH. I think that these are good ways to meet the members at the grassroots and get involved where their passions lie.

With the Area Council, I've been participating on the Phoenix Sub-Committee and attended both Canada Day in Surrey and Labour Day, which also took place in Surrey this year. I think we did a lot of great work getting out and speaking to the public about Phoenix and it's impacts on our members, and getting cards signed by members of the public in support of our call to fix Phoenix. There was already a great deal of knowledge from the public about the issues around Phoenix but being able to tell people our members' stories just brought it home and made it more relatable for them. Sky's idea to have a "Wheel of Misfortune" was a great idea to get the conversation started and draw people in to our booths at events, and I'm hoping that the Region is seriously considering purchasing a wheel of our own that we can customize to campaigns and use throughout the region. At our meetings, we worked on Resolutions to submit to the National Triennial Convention and did a lot of work around Phoenix and how to engage members and the public in our campaign. There were also discussions about MP Lobbying.

I had planned on attending the Area Council Barbeque and Softball Tournament, but was not able to get the time off to attend, which was disappointing to me, I think it would have been a great venue to meet with my constituents in a more casual atmosphere. I did participate in the Phoenix Awareness event on August 31 at Library Square, where we had members take the Fix Phoenix banner go out into the intersection during light intervals to get the message out, while others spoke to members as they were leaving the worksite to engage them on Phoenix.

With the Women's Committee, we have continued to work on the Shoebox Project Campaign, which will be coming to its culmination on November 15, 2017 with our Packing Party. I'm happy to report that the Committee raised nearly \$2000.00 through the sale of Pink Pussy Hats. Through the generosity of members not only in BC, but at Conventions and Conferences across the country we are going to be able



to donate at least 50 boxes of little luxuries to the Vancouver Shoebox Project. This has been a passionate goal for me all year, and I am so proud of the Women's Committee for running with it. It's going to be an exciting night of making gifts for women in need, socializing and community. I hope that everyone will put the word out and get their members out to give us a hand. If you or your Local or your Component would like to donate a box, there's still time. Please go to the website, www.shoeboxproject.com/vancouver.html for details on what items are needed (and which ones are not).

While I was not able to attend many events with the Human Rights Committee this summer, I was able to attend the regular meetings either in person or over the phone. I'm hoping to be able to participate a bit more throughout the rest of the year. I was able to attend the Sister's In Spirit Vigil on October 4, just before preparing this report. It was both deeply sorrowful and incredibly inspirational to hear from leaders in the community and members of the families of the Murdered and Missing Indigenous Women and Girls. I don't know if I could be as strong as some of the women who spoke after the experiences that they have been through.

BRUSH was relatively quiet over the summer due to the Component Convention Cycle and it just being summer, but we did have a very informative meeting in July which included information on Fentanyl Exposure, which many of our members face in the work that they do. I think that this is an emerging issue that we will need to find ways to address. I found out that my own employer does not have any sort of protocol, other than a general chemical exposure protocol, something that I will need to work at on my Health & Safety Committee.

In September, I attended my Component Convention in Mississauga. It was a challenging Convention, with some disappointments, but overall, we did good work on resolutions and building relationships. The travel was long with a re-route through Ottawa to respect the strike at Pearson, but I must admit that the extra time on the train did give me time to work on Bargaining Demands for my upcoming Bargaining Conference for Purolator.

Upcoming for me are attending a BRUSH meeting in October, my own Local's Bargaining Conference, Phoenix Sub-Committee conference call, a Fix Phoenix event in downtown Vancouver on October 18 and of course the Women's Committee Shoebox Project packing party.

I'm hoping to be able to plan with the other Metro Vancouver Coordinators some site visits to see members where they work. I'd like to plan to go into the Canada Post plant in Richmond, as these members seem disengaged from the union, both on a regional and a component level. I'd like to be able to reach out to find out what we can do to get these members re-engaged. I'm keeping my fingers crossed that some of the vacant positions in my local will be filled and it will be easier to take some time to get out for more member to member engagement.



### June 2017 to October 2017

At the last PSAC Regional Convention in June, I was sworn in as the Geographic Coordinator for Northwest, B.C. Since the convention I have:

1. Participated in the Regional Council Teleconferences, of September 13, 2017 and October 3, 2017.

### 2. Phoenix Pay Issues

- In my office Phoenix pay issues continue to be prevalent and unresolved now over two tax years. While I was at the convention in June, I organized for an Alternative NPSW event at my office in relation to Phoenix pay problems to show management our discontent with the situation. Participants in this alternative event included our PSAC members and PIPSC members. I continue to keep pay issues on each local Union-Management meeting agenda.
- Upcoming actions planned: I have arranged for a Rally at Lunch on October 18, 2017 at Nathan Cullen's Office in Prince Rupert. PIPSC and Unifor staff will be participating along with our members. October 18, 2017, parliament is in session and Nathan Cullen will not be at his office, but he has agreed to hear the concerns of one of our severely impacted members; the date for this is still to be arranged.
- I have shared details of, and I will participate in the October 5 Phoenix public awareness committee conference call.
- 3. Revitalized the Northwest BC Area Council I did a lot of ground work contacting members in the northwest geographic area to determine interest in revitalizing the Northwest BC Area Council. Interest was there! I arranged a meeting and we had great participation. Jamey Mills and Deanna Kimball were at our meeting in person, which greatly contributed to the meetings success. The Area Council was revitalized and we plan to call the next AGM in January 2017 (date still to be determined). Prior to the next meeting I have some more work to do: Regional office is going to work with me to revise our by-laws so that they are in alignment with our Constitution and they are also going to offer me some suggestions that have proved useful to other Area Councils.

### 4. Education

- Introduction to the Union for Indigenous Members. October 20-22 | will

## 6. Indigenous issues

- Liaised with Giselle Henry in regard to her leading a Sacred Water Ceremony in Prince Rupert.
- Attended a dinner with the Tears4Justice walkers. A dinner was hosted for them as a send-off event prior to their walk from Prince Rupert to Smithers. This was a significant walk as their purpose was to raise awareness to the cause meet up with the last stop of the Missing and Murdered Indigenous Women's Inquiry. I had opportunity to present the walkers with \$600 (\$300 from the BC Regional Council and \$300 from Todd Panas, President, UHEW).



#### Plans for the upcoming months include:

1. Conduct site visit in Prince Rupert on Oct. 18 prior to our Lunch time Phoenix rally at Nathan Cullen's office to remind and garner the best participation for the rally that I can.

## September 2017

On September 5, 2017 Vanessa Miller (National Officer, CEIU BC/YT NVP and Alternate Geographic coordinator for North Vancouver Island, James Brierley (PSAC Young Workers Coordinator), Robert Strang (PSAC Representative) and myself (Geographic Coordinator for the BC Southern Interior) toured through the Okanagan talking to members about local issues including staffing and the Phoenix pay system.

We started the day at the Service Canada office in Kelowna where we spoke to CSOs at the front counter and Integrity staff where members raised a number of issues

mainly related to pay. The members were given Vanessa Miller's contact information so she could follow up on their complaints. We also attempted to speak to Veterans Affairs staff at this site without success but we did have a brief conversation with the site manager. We stopped in at the Kelowna Airport and spoke with regional CBSA president Don Turner and some of the members.

We continued on to Penticton and on the way we gave a telephone interview to rabble.ca where we explained the variety of ongoing pay issues affecting our members and the effect it has had on them. We also arranged for a member at the Service Canada office in Kamloops (Christine Harrington) to be interviewed. This member has been off work for a year because of health issues related to her pay problems. The interview was recently published online. We went the Service Canada site to find clients lined up out the door so we moved on to a pre-arranged lunch meeting with Veterans Affairs and Measurement Canada members where the



main topic continued to be Phoenix pay issues. After lunch we stopped in and said hi to Derek Morrison the president of Canada Revenue Agency site in Penticton.

Our last stop of the day was the Osoyoos CBSA site where we met up with Carolyn McGillivray, the other BC Geographic Coordinator for the BC Southern Interior, and we spoke a number of members who again wanted to discuss staffing and pay issues. We were given a thorough tour of the site and exchanged contact information with some of the members.

The next day (September 6, 2017) we were joined by Stephen Klaver (Alternate CEIU BC/YT NVP and Alternate Geographic coordinator for West Fraser Valley) and Eddy Bourque (CEIU National President) and we headed to Kamloops for site visits and a rally. We visited both Service Canada Sites in Kamloops and spent quite a while speaking with members. We encouraged them to join us at noon for a rally at Conservative MP Cathy McLeod's office about the Phoenix pay system. About 40 or 50 people attended the rally. A few members shared personal stories about how Phoenix has affected them financially and emotionally including one member with a \$23000 overpayment and health issues related to her pay problems. All of us addressed the members who expressed their escalating frustration with the Phoenix pay system. Barb Nederpel (BC NDP MLA candidate for Kamloops North and Kamloops District Labour Council President) also attended and spoke to members, voicing her support and frustration with the ongoing pay issues.

We returned to Kelowna and went UBC Okanagan in the evening to attend a Liberal town hall hosted by Prime Minister Justin Trudeau. We tried to get Mr. Trudeau's attention in order to ask questions about the Phoenix pay system and the closure of the IRCC Case Processing Center in Vegreville, Alberta but he chose to ignore us and called on other (seemingly pre-selected) audience members where Mr. Trudeau appeared to have the answers well planned in advance. We did manage at one point to get his attention with our Fix Phoenix signs but he just moved to a different area of the stage so we wouldn't be in the camera angle. We did manage to have our pictures taken by a few photographers at the end of the night holding our Respect Vegreville and Fix Phoenix signs.

The next day we attended another Phoenix rally at Kelowna Liberal MP Stephen Fuhr's office with the CEIU BC/YT Regional Council. Mr. Fuhr was not present but a number of members gave media interviews which appeared in different print media over the next few days. It was a great few days and I look forward to more activities in the near future.

I have attended some conference calls of the Regional Council and one for the Political Action Committee.



Thank you for the honour of being re-elected to the position of South Vancouver Island co-ordinator for the BC Regional Council.

Since convention in June I have been busy in the Region and my component. I assisted the VIHRC in the planning for the pride parade in Victoria. I collected and distributed the materials for the parade.

At the 2017 PSAC BC Convention I was elected coordinator for South Vancouver Island. As I begin my first full term in this position, I am honoured to be a voice for the members of South Vancouver Island.

I have attended two Victoria Area council meetings, and wrote the only resolution our Area Council sent forward for the Triennial Convention. We will be having our Annual General Meeting on October 17, 2017.

I have attended the Victoria Woman's Committee, which has been struggling with attendance and direction. The Annual General meeting will be held on November 1, 2017.

I attended the UNDE Phoenix and contracting out rally. The event was well attended with approximately 200 members blocking the entrance to the base. At the end of the rally, the members marched up on DND property to the gate house.

I met with Colleen Girard the other South Island Coordinator to discuss some goals for the upcoming year, and set out the start of a plan.

On the Labour day weekend I was at the PSAC Victoria Area Council booth at the Saanich Fair. We average speaking to about 50 people an hour over the weekend and almost 100,000 people pass through the gates. There was a lot of discussion about

Like many of our committees, we are struggling with membership and volunteers, especially over a long weekend.

I am helping organize the October 18, 2017 Phoenix rally in Victoria BC, which I plan to attend. At the in-person meeting, I will provide an update on how the event goes.

## Challenges you had to cope with:

Finding a good balance between work/ Life/Union I have been looking after my sister for the past two years, as well as my own health issues. Reminding myself that Its okay to take time for myself and that I don't have to do it all.

#### What would you like to work on next?

My primary focus over the rest of my term as Coordinator, is membership engagement and communication. Our members want good and clear communications from our leaders about our issues and goals. They want opportunities to have a voice in our union, a say in decisions that affect us, a chance to contribute their ideas. After much discussion membership doesn't appear to understand how to get their issues heard, or who to contact to be their voice. They are also not confident that anyone is really listening.

#### **Members with Disabilities Coordinator:**


- August 24, I made an affiliation request to the Vancouver and District Labour Council.

The Victoria RWC AGM is taking place November 1st.

#### Regional Ongoing Initiatives:

Affordable Child Care Plan, to put "positive pressure" on the Provincial Government for their support and Funding to see the BC roll out the affordable child care plan.

Currently, the Federal Government has committed \$50M, Provincial Government needs to budget \$175M in 2018 to reach the magic number of \$225 necessary for BC's Affordable child care plan. The \$225 will:

- Reduce parent fees by \$500/month in all licensed infant and toddler spaces
- Wage enhance of \$1/hr for all early childhood educators
- Eliminate parent fees for families with annual income less than \$40K
- Create 22,500 new licensed spaces by 2020

The plan will pay for it-self within seven years as more stay-at-home parents are able to enter the workforce, subsequently contributing Income tax.

## BC Fed Women's Rights Standing Committee:

I attended the BC Federation of Labour Women's Rights Standing Committee meeting on July 5, 2017.

Action Items the Committee is working on include:

- promote endingviolence.org
- support "Be more than a Bystander" campaign

Thank you for finding the confidence in me to be your Pride Coordinator at the 2017 PSAC BC Convention.

On July 9th I attended my first event as the Pride coordinator. I marched in the Pride Parade along side Jamey Mills, Todd Smith, Vanessa Miller and others. I also spoke with the Pride Director about the present of the Victoria Police in future pride parades. He is looking to have only the LGBT members of the force and them to be out of uniform. The uniform often represents oppression to many of the marginalized in the LGBT+ community.

On August 6th I attended the Vancouver Pride Parade and marched with Jamey Mills, Todd Smith, Sky Belt and other members. It was amazing to see the equality, diversity and inclusion in the parade and in the crowds that number in the thousands.

This upcoming year I hope to aid our members who work the front line and on the phones on how to deal with gender non-conforming clients especially those clients who have not legally changed their name/gender on our systems. Our members deserve to have the proper tools to deal with such situations.

I would like to work towards having at least one gender neutral bathroom in all federal buildings. Gender neutral bathrooms are a way to create a safer environment for trans and gender nonconforming members.





I also hope to look into possibly having union floats and/or booths at certain 2018 pride events depending on costs and member participation.

I would be remiss if I did not take the Union to task. Before I go to the employer and fight for the Trans community and Trans members we need to fix the Union first. We need to fix the language of our Union. For example there is widespread cultural practice of calling members brothers and sisters. This excludes all other genders, and reinforces the binary. We must replace brothers and sister with inclusive language. We also must ensure that every union function has a gender neutral bathroom. I should not go to a National Equity Conference and have the PSAC not be able to get it together enough to have a fully functioning gender neutral bathroom.

To my LGB colleagues my apology if my focus is on Trans issues. It is what I know and what I live. Please come to me with any issues that need to be addressed.

# Activity Report for Jennifer Chieh Ho, PSAC BC Regional Co-Ordinator for Racially Visible Members

**July 2017 – September 2017** 

It was an honour to be re elected for the role of PSAC BC Regional Co-Ordinator for Racially Visible Members at the PSAC BC Regional Convention in June 2017. I am pleased to welcome and introduce the two alternates, Stephen Torng and Eamon Myagi. We look forward to working with the 2017 – 2020 BC Regional Council and the members in our Racially Visible (RV in short) caucus.

At the March 2017 PSAC National Equity Conference for Racially Visible workers in Toronto, both Stephen and I had the opportunity to attend a workshop on Racism "Impact of Systemic and Structural Racism in Our Workplaces" facilitated by our very own PSAC BC regional representative, Monica Urrutia.

Workshop description: Impact of Systemic and Structural Racism in Our Workplaces – Racism exists today, even though we have systems and processes such as human rights and employment equity legislation to address it. This workshop will examine how racism in society (e.g. justice system, immigration, education, political systems, etc.) continues to create barriers and impacts career opportunities for RV workers.

Stephen and I approached Monica to discuss making this workshop available to our Racially Visible members who were not able to attend the Conference. We had a date set for our first RV meeting and the offer of this specific workshop in September.

Unfortunately, due to low number of registrants, the workshop did not take place. We continue to consider further dates soon.

## **Union of National Employees Triennial Convention – August 2017**

I have reached my two term limits as the Regional Vice President of BC and Yukon in August of 2017. It was my honor to be acclaimed as the BC Yukon Regional Human Rights Representative.

On August 27, the last day of our convention, two young workers from UNE Whitehorse, Yukon region came up with an idea of doing a rally on Phoenix at the Parliament Hill. As it was a spontaneous rally being suggested by these two young workers, we did not get a permit ahead. When we got to the Hill, I approached the police officer who was on

duty to explain what we were doing, and we got approval right on the spot. We got to educate the public on what the issue was and received support from most of them.

Thanks to the West Fraser Valley Area Council and members who came to help out at the booth, we had over 400 "Fix the Pay System" postcards completed. We talked to lots of people about Phoenix and definitely brought awareness to lots who had no clue. At the same time, there were lots who were aware of the situation.

The bill "does not address Canadians' concerns about being interrogated, detained and turned back at the border based on race, religion, travel history or birthplace as a result of policies that may contravene the Canadian Charter of Rights and Freedoms," NDP public safety critic Matthew Dube said in putting forward a motion that could effectively kill the bill.

"What we're seeing right now is a reality where people are being discriminated against at the border," Dube told reporters."

Dear Senators and Minister Goodale,

I am writing to you to express my concern with Bill C-23. While I recognize the benefits preclearance brings about for tourism and trade with the US, I strongly believe the issues around the rights and freedoms of Canadian travelers must be addressed before this bill is passed by the Senate.

Travelers must have the right to withdraw from a preclearance area, the powers of interrogation, search and detention given to US border officers must be checked and there must be sufficient ability for Canada to assert criminal jurisdiction if the US does not prosecute appropriately.

As a concerned citizen, I urge you to oppose the bill in its current form. For more information on the concerns I have raised in this e-mail, please review the submission of the British Columbia Civil Liberties Association.

We must ensure that Bill C-23 upholds the Canadian Charter and protects Canadian travelers' fundamental rights and freedoms. The bill cannot pass in its current form.
