The Observer registration information is scheduled to be posted on the PSAC website in December. The committee was unsure if this had been done before. Deanna will follow up with the REVP and other Regional Reps to seek their advice on how to do this if it is the will of the committee. Wendy stated that there is a Funding Request form that has been developed and finalized, for funding requests to the committee. It was suggested that a draft budget be provided if someone was going to ask for funding to the convention. It probably wouldn't be feasible for the committee to solely send an observer as the cost would be too great. The committee agreed to discuss this at the next meeting further provided the research on costing is done.

Deanna will resend out the funding form and it should be posted on the regional website for members to access.

9) Transgender Day of Remembrance - November 20

The committee acknowledged that was the Transgender Day of Remembrance and watched a video:

**Transgender Day of Remembrance** (TDoR), which occurs annually on November 20, is a day to memorialize those who have been killed as a result of <u>transphobia<sup>[1]</sup></u> (the hatred or fear of transgender and gender non-conforming people) and to bring attention to the continued violence endured by the <u>transgender</u> community.<sup>[2]</sup>

The Transgender Day of Remembrance was founded in 1999 by <u>Gwendolyn Ann Smith</u>, a <u>trans</u> <u>woman</u> who is a graphic designer, columnist, and activist,<sup>[3]</sup> to memorialize the murder of <u>Rita</u> <u>Hester</u> in <u>Allston, Massachusetts</u>.<sup>[4]</sup> Since its inception, TDoR has been held annually on November 20, <sup>[5]</sup> and it has slowly evolved from the <u>web</u>-based project started by Smith into an international day of action. In 2010, TDoR was observed in over 185 cities throughout more than 20 countries.<sup>[6]</sup>

Typically, a TDoR memorial includes a reading of the names of those who lost their lives during the previous year, <sup>[7]</sup> and may include other actions, such as candlelight vigils, art shows, food drives, film screenings, and marches.<sup>[8]</sup> The TDoR is the culmination of <u>Transgender Awareness</u> <u>Week.<sup>[9]</sup> The Gay & Lesbian Alliance Against Defamation</u> (GLAAD) has extensively covered TDoR.<sup>[10]</sup> GLAAD has interviewed numerous transgender advocates<sup>[11]</sup> (including actress <u>Candis</u> <u>Cayne<sup>[12]</sup></u>), profiled an event at the <u>New York City LGBT Community Center</u>,<sup>[13]</sup> and discussed media coverage of TDoR.<sup>[14]</sup>

10) Hanna and Ameila Fundraising Event Report

I would like to thank the Women's Committee and the Human Rights Committee for purchasing tickets for the Hannah and Amelia Fundraising Dinner.

This was my first time I attended the second annual Hannah and Amelia Fundraiser dinner with Sandy Chatha and Kelly Sidhu, and I can certainly say, it was a very well supported fundraiser by people in the community, from different backgrounds and cultures.

This sold out fundraiser was put on by Dina in memory of her two daughters Hannah who was still born on June 15, 2016 at 28 weeks and Amelia who was still born on May 3, 2008 at 26 weeks. As a result of this, Dina had suffered deep depression for many years. With strong support from her husband, family and friends she was able to regain her strength and move forward in her life. Dina decided to set up a foundation in the name of her daughters to improve the lives of children, in particular girls. Girls are viewed as a burden in many parts of the world, including India. Therefore, this foundation is raising monies to bring hope, joy and help to girls living in an orphanage.

Dina spoke about the loss of her daughters, the depression she suffered, and the decision to raise monies and help build playgrounds in orphanages in other countries. A video was displayed sharing stories from girls living in orphanages and their struggles. Last year, the foundation raised 25,000 dollars that was used to build a playground for girls, in an orphanage in Jallandar, India. This year, the goal is to raise another \$25,000 dollars that will go towards building a playground for an orphanage in Chandigarh, India, and a simple thing like a playground will help to provide these opportunities.

Helping children, in particular girls, is very heart-warming; therefore, I would like to see that this event is supported and attended by PSAC members annually.
