REPORT OF THE REGIONAL EXECUTIVE VICE-PRESIDENT November 2017 to February 2018

Not surprisingly, these last few months have been equally as busy as the months that followed our Regional Convention. With the ongoing Phoenix pay system disaster, outstanding bargaining for FB, CFIA, Parks, Canada Post, CRA, and our regional units, as wells as the forthcoming PSAC National Bargaining Conference and the PSAC National Triennial Convention, it's been a challenge to ensure there are sufficient resources available to fulfill our other regional responsibilities. Nonetheless, I'm happy to report that PSAC BC members and staff have rolled up their sleeves to take up the tasks of ensuring members' needs are met and our priorities are upheld to the best of our abilities.

On the Phoenix pay system disaster, it has been a trying time for our membership – both those who have been directly affected and those who have not. The amount of time and energy we have focused on treating the systemic problems, and the financial impact that Phoenix has had on our membership and on our organization as whole, have inevitably consumed the bulk of our attention over the past year and are carrying forward into 2018. Two years into this disease that is Phoenix, I empathize with our members from coast to coast to coast; enough is enough. The Liberal government must start taking significant action that will address the systemic illness at hand because we cannot continue to solely address the symptoms of Phoenix alone.

Political Action and Campaigns

Phoenix Pay System

As you'll know from my previous report, one of my key priorities since being elected has been the Phoenix pay system debacle and bringing further public awareness to the struggles our members, and all federal public service workers, continue to face with each passing pay period.

As I reported in the fall, this past summer I penned an open letter to all 42 MPs in BC regarding the Phoenix pay system. In my letter, I called on our MPs to take a stand and speak out on behalf of their constituents who have been affected by the Phoenix pay system disaster and to call on the Federal Government to fix Phoenix, ensure that our members are paid correctly and on time, and to treat all federal public service workers with the respect we deserve.

Over the fall, and now carrying in the winter months, many of the MPs reached out to me in response to the letter. Several MPs have also requested meetings with me to discuss the Phoenix situation in depth, asking what the PSAC is calling for and how they can assist their constituents who have been affected. For the most part, I have attended the meetings along with at least one other PSAC member who is a constituent in the MP's riding. I have also encouraged our PSAC BC members to reach out to their

MPs to request similar meetings. Thus far, I would estimate that we've been able to meet with half of the 42 MPs in BC to discuss Phoenix, collective bargaining issues, privatization, Bill C-27, and child care.

Phoenix Rallies and Workplace Actions

As you may recall, while we were attending the October NBoD meeting, PSAC BC members organized several, grassroots Phoenix workplace rallies on October 18. Rallies were held in Victoria, Chilliwack, Vancouver, Prince Rupert and Nanaimo, which garnered significant media attention.

Stemming from the success of October 18, the Region established a province-wide Phoenix Public Awareness Committee to organize further Phoenix activities in BC. The Committee includes members from the BC's Area Councils and the BC Regional Council's Political Action Committee. The Committee's went on to plan and execute several actions during the week of December 11-15, the week members received their last paycheck before the Christmas.



In Vancouver, members rallied at Harbour Centre on December 13, calling on the Liberal government to take measures necessary to ensure workers are paid correctly and on time. Members sang a few Christmas carols (Jingle Bells, Phoenix smell!) and heard from members who have been directly affected by the pay system errors. Media was on hand for the event and they interviewed our members for radio, print and television news. Also on December 13, members rallied against Phoenix at MP Mark Strahl's office in Chilliwack. During the rally, USJE members spoke to the media about their frustrations with the pay system and the negative impact it's having not just in their bank accounts,

but also at their workplace, creating an undesirable work environment for casual hires. More information on the media coverage is available at https://www.surreynowleader.com/news/frustrated-federal-workers-rally-against-phoenix-payroll-system-at-b-c-mps-office/.

And on December 15, members in Prince Rupert got together over their coffee break to send a message to the Prime Minister. The card to Prime Minister Trudeau read as follows, "It is with great regret that we inform you that you are on the naughty list of PSAC members throughout Northwest BC this holiday season. As such, enclosed you will find your holiday gift from us: a lump of coal straight from the Ridley Coal Terminal and some cards signed by federal government workers." FB Rally

In addition to our Phoenix public awareness events in December, Customs and Immigration Union (CIU) members demonstrated near the Douglas Border crossing on December 14 and at Pacific Highway Border Crossing on February 14. The demonstrations were in support of ongoing national bargaining efforts for a new collective agreement for members of the FB group and to create some public awareness regarding the outstanding FB bargaining. The demonstrations were organized as part of the PSAC and CIU coast-to-coast campaign aimed at reminding Canadians that Border Service Officers keep the country's borders safe and that they deserve to be treated as law enforcement officers by the government.

The December 14 demonstration attracted some media attention, and CIU National Vice-President Richard Savage, who was in attendance, was quoted as saying, "We're now 3½ years without a contract and our officers are just getting tired." (See https://www.peacearchnews.com/news/border-officers-getting-tired-of-lack-of-respect/) As FB members continue to wait out the long PIC process, we will continue to give our support and solidarity to the members with these mobilization efforts.



I'm confident that PSAC members will continue to hold these types of events – both within the membership and with the public – over the coming weeks and months to hold the Liberal government accountable for the Phoenix Pay System disaster, for the outstanding collective bargaining, and to remind the Liberal government of their pledge to show our members the respect they deserve. Already, our BC Phoenix Public Awareness Committee

is making plans for further worksite actions to mark the upcoming two-year anniversary of the Phoenix Pay System rollout at the end of February.

Phoenix Steward/Pay Advocate Assemblies

Across the country, the PSAC organized Phoenix Steward/Pay Advocate Assemblies to provide training for pay advocates (normally local officers or stewards) who have been assisting members with Phoenix issues. In BC, three assemblies took place:

- January 27, Richmond
- January 28, Abbotsford
- February 10, Victoria

Assembly participants received information and training on tools specifically for assisting those with pay issues. The assemblies also provided information on our key objectives in pressuring the government to address and resolve Phoenix. Along with regional office staff, I attended the three assembly dates and hope that the training provided will better equip our members to deal with Phoenix-related pay problems.

It should be noted that originally two further dates had been planned for the Southern Interior and the North. However, due to low enrolment those two sessions were cancelled. In lieu of those two assemblies, some lunch'n learn opportunities were organized in those areas to ensure that members have the supports and information they need to continue addressing Phoenix issues.

Building Alliances and Supporting the Labour Community

BC Federation of Labour Union Renewal Conference

In late October union activists from across BC came together in Victoria to attend the BC Federation of Labour (BCFED) Union Renewal Conference. As in past years, the aim of the conference was to look at initiatives to promote good jobs and strong communities, both locally and provincially.

The conference took place over three-days under the theme "Making Work Work for Everyone," and explored strategies to help us respond to our changing workplaces. Participants had the opportunity to learn about a wide range of initiatives, which focused on three emerging themes: changing workplace demographics, the rise of precarious work, and broader economic shifts such as the impact of continued globalization, emerging technology and automation.

I attended the conference and participated in great discussions and skill development workshops. I heard from other unions regarding their strategies for organizing, member engagement and mobilization. Connecting with elected officials and activists from other unions in formats such as this BCFED conference will enable BC's labour community to work more closely toward our common goals and achieve of shared successes.

Canada-Wide Day of Action in Support of Tim Hortons Workers

The BCFED's Fight for \$15 campaign and its partners organized events in the Lower Mainland as part of the CLC's Canada-Wide Day of Action in support of Tim Hortons workers. Together, BCFED Affiliates and the PSAC participated in information leafleting and sign waving events Tim Hortons locations on Friday, January 19. I attended an afternoon event in Vancouver along with other PSAC members and sent Tim Hortons franchise owners and its parent company, Restaurant Brands International a strong message: we won't let you bully workers!



March on Vancouver

Along with other unions in BC, the PSAC BC Region participated in the January 20 "March on Vancouver" in support of equality, diversity and inclusion. The march marked the anniversary of the 2017 Women's March, which was organized in response election of the 45th President in the United States and as part of a global movement to harness the political power of diverse women and their communities to create transformative social change.

Last year, over 15,000 people took place in the Women's March in Vancouver in solidarity with a world-wide movement of grassroots resistance and this year's event was equally well attended.

The 2018 march built on last year's energy and momentum, and marchers came together to reject the hate that damages our communities – women, Indigenous people, racialized people, Muslims, Jews, members of the LGBTQ2+ communities, disabled people, migrants and those with precarious or no legal status. I am proud to have participated, shoulder to shoulder with other PSAC members and other BC labour activists in an action that aims to dismantle systems of oppression through nonviolent resistance and build inclusive structures guided by self-determination, dignity and respect.

CLC Ranking Officers Seminar

Every year, during the CLC Pacific Winter School, the ranking officers from each of the Affiliates of the BC Federation of Labour meet in Harrison for a four-day seminar to discuss priorities, campaigns, political action and the direction of BC's labour movement for the next year.

This year's ranking officers' seminar is scheduled for January 29-February 1, and I am looking forward to meeting with the senior ranking officials from BC's labour movement. I have every expectation that we will continue our conversation on holding

the new BC NDP Government accountable for their election promises, including the implementation of a \$15/hour minimum wage, establishing a provincial childcare plan, creating a poverty reduction strategy that will ensure the needs of all British Columbians are met and that people are put before profits.

During the seminar, I've also been asked to provide a presentation (in the PechaKucha model) to the Ranking Officers on our Fix Phoenix! Campaign, with both a national and a regional lens.

Regional Negotiations

There are several units are currently in negotiations in the B.C. Region:

- **Granville Island** A collective agreement was ratified in October.
- IMP Comox The arbitration process is still ongoing. However, the employer is continuing to drag their feet despite the serious problems in the workplace that need to be addressed. The bargaining team is pushing back, asking that the arbitration be done through written submissions instead of an in-person hearing. Our hope is that this will help settle the collective agreement sooner than later. The Arbitrator has agreed and the parties exchanged their arbitration briefs in January.
- First Nations Health Authority Bargaining dates are scheduled for the end of February. The unit is having some challenges with the Employer who has recently made some changes the group's travel policy, which would appear to be a change to the terms of employment during the bargaining process. Consequently, the team is looking into whether or not to file an unfair labour practice.
- Commissionaires A tentative agreement was ratified in early November. The
 agreement included improvements regarding bereavement leave, staffing and
 seniority articles.
- Sealcove Commissionaires in Prince Rupert There has been no movement with this group. The Employer is seeking significant rollbacks, so members are currently enjoying a statutory freeze. If they go to the table, they will face concessions.
- **ARINC** The unit is located at YVR and includes 18 members. A tentative agreement was ratified on October 30, 2017. The agreement includes the introduction of a long-term service premium.
- North Peace Airport We have served the employer with notice to bargain, but do not have dates yet.
- **Prince Rupert Airport** The input call for bargaining demands has gone out.
- Purolator The first set of meetings with the employer is still the process of being scheduled. We hope the be at the table in January or early February.
- Swissport Supervisors & Admin (YVR) The input call for bargaining demands has gone out.

With respect to the unit at IMP Comox, in early February I travelled to Comox to meet with the UNDE members along with UNDE Vice President T. Mark Miller and PSAC negotiator Morgan Gay. The aim of the worksite visits was to encourage further member mobilization despite the Employer protracting this round of bargaining.

Education

Regional Education Schedule

At the end of January, we began rolling out the Region's winter/spring education schedule across BC. In particular, we will be holding 17 separate 1- and 2-day basic weekend courses in BC between January and early June. Courses include: Talking Union Basics, Grievance Handling, Local Officers Training, ABCs of UMCs, Steward Series II, Bargaining from Strength, H&S Activism, H&S CLC Pt. II, and Duty to Accommodate.

On January 13-14, BC was the second Region to host Advocating and Representing Against Workplace Racial Discrimination. This is a relatively new course that was developed in the NCR, in which participants learn how to support racialized and indigenous members who are victims of racism and identify appropriate means of resolving workplace racial discrimination.

In early February the BC Region had its second offering of the Advanced Representation Training for Stewards (ARTS) course. As you may know, this course was piloted in BC in October 2015 and built upon the former Advanced Steward Training. The four-day ARTS course looks at various routes for engaging members, helping them to resolve workplace issues.

Regional Activities

December 6th Vigils

PSAC members, along with the New Westminster & District Labour Council and the Kwantlen University Students Association, helped organize a candlelight vigil at Holland Park in Surrey on December 6th, the National Day of Remembrance and Action on Violence Against Women.

This is an annual event our members organize to commemorate the victims of the Montreal Massacre and each life taken by violence against women and gender-based violence in all forms.



Sacred Water Ceremony

In Victoria, members of local First Nations, PSAC, and BCGEU, along with Elizabeth May, Leader of the Green Party of Canada, and the Honourable Judith Guichon, Lieutenant Governor of British Columbia all gathered at the Sacred Water Ceremony on December 10, International Human Rights Day. The ceremony was organized by members of the PSAC Vancouver Island Human Rights Committee, NAPC and BCGEU to raise awareness on the lack of safe drinking water in First Nations communities and to remind the Liberal government of their promise to end boil-water advisories on First Nations reserve within the next five years. As of July 31, 2017, there were a total of 121 First Nations under drinking water advisories across Canada, despite the fact the access to clean and safe drinking water is a basic human right. Pre-Convention Strategy Session of BC Delegates

The BC Region has traditionally held a one-day Pre-Convention Strategy meeting for BC delegates prior to the PSAC National Triennial Convention. The budget for this meeting is included as part of the PSAC BC Priority Proposal, passed at our BC Regional Convention. The purpose of the meeting is to provide BC delegates with a forum to discuss resolutions, Committee reports and priority lists, and to strategize as appropriate on regional priorities.

Planning is well underway for the Pre-Convention Strategy meeting, which is scheduled to take place Saturday, April 7 in Vancouver.

Member Engagement

With AGM season upon us, I have been busy attending Local, Area Council and Committee meetings over recent weeks. I've used these occasions to speak to members about the Phoenix Pay System debacle and collective bargaining, but also as an opportunity to talk with members about getting more engaged in the PSAC, political action and union activities.

My hope is that these conversations will lead to even greater participation in our PSAC and Components structures. In the past year, we've seen a number committees go from virtual inactivity to thriving, grassroots networks with many emerging activists. I will continue to support this member engagement is any way that I'm able.

PSAC Alternate REVP-B.C. - Todd Smith Report to the B.C. Regional Council

Since my last report I've had opportunities to meet members at their workplaces, Phoenix rallies, Young Workers and Human Rights committee meetings, and other functions. It is clear that Phoenix is the biggest issue affecting the majority of our membership. I have been involved with a number of Phoenix-related activities including two rallies, two region-wide Phoenix Public Awareness Sub-Committee calls, attended a constituency meeting with Johann Ackermann to talk about Phoenix with PSPC Minister Carla Qualtrough, and was part of a rally on Parliament Hill which saw excellent national media coverage. We have been incredibly engaged and active here in BC; we've got an excellent opportunity to build on our momentum.

In October I was sworn in as an Executive Council member of the BC Federation of Labour. I'm excited and grateful for the opportunity to represent our membership at the BC Fed. Following the Executive Council meeting I attended the Union Renewal Conference put on by the BC Fed. The conference included a wide range of speakers on current issues including \$10 a day Child Care, \$15 minimum wage, Indigenous rights, and included workshops on a variety of relevant topics. Premier Horgan addressed the conference delegates highlighting some of his government's accomplishments since the election and spoke about going forward with labour as an engaged ally.

I've had a number of opportunities to support human rights and equity. I'm thankful to have been invited to a screening of Migrant Dreams put on by our Okanagan Human Rights Committee in October. A number of community and labour organizations also attended including Radical Acton with Migrants in Agriculture (RAMA) and the North Okanagan Labour Council. The event was well attended and very informative. On December 10th, Human Rights Day, I had the privilege of attending a Sacred Water Ceremony in Victoria where labour and community activists heard from a number of speakers on the lack of access to clean drinking water in many First Nations communities. In January I attended the Women's March in Vancouver with a number of members and many allies. In addition to these events I also attended the regular meeting of the Mainland Human Rights Committee.

I'm grateful and excited to have been accepted to the CLC's Labour College of Canada Certificate Program and be a recipient of one of PSAC's scholarships. The program started the first week of January with the a module on Political Economics. I'm looking forward to this learning opportunity and developing relationships with fellow unionists from across Canada.

Over the next few months I will continue engaging with our members on issues affecting us—especially Phoenix—and also continue engagement with our communities.

PSAC Geographic Coordinator for Metro Vancouver - Jennifer Horsley Report to the B.C. Regional Council - Activities Since my last report

Since my last report, I have been working with the other Metro Vancouver Coordinators and Alternate REVP Todd Smith on Phoenix rallies, on the 18th of October and December 13th, both of which were quite successful in drawing out members despite the weather, rainy at the first and freezing at the second. I am looking forward to what will happen for the national day of action in February, which will probably be discussed at the upcoming Vancouver Area Council AGM on January 31st.

I am very proud of the work that the Vancouver Regional Women's Committee did on the Shoebox Project over the past year, and the culmination was the packing party on the 15th of November. I would like to acknowledge all of the hard work of the women who came out and the generosity of the Locals that donated so many items that with our fundraising efforts and the donations we were able to surpass our goal of 50 boxes of little luxuries for women in shelters and put together over 70 boxes. What a rewarding feeling it was to be able to provide so much for such a



worthy project. It has definitely left a lasting impression on me, and I will continue to contribute on my own, not as much, but definitely going to carry on with knitting to be added to boxes and maybe do a few boxes on my own over the coming years.

My Local Bargaining Conference went well. We elected a bargaining team, including myself, and we discussed a lot of proposals and came up with our priorities. The only issue now is securing dates with the employer. Unfortunately, we have been having scheduling problems.

The National Leadership Training in Ottawa was probably the biggest activity of this period, allowing me to make connections and get ideas from other leaders from across our union and the country. The workshops for the most part were very informative, and the speakers were amazing. The Leadership Style workshop gave me some real insight on how I work with others and ideas about how to work with other leadership styles. Hoping to put all of the information to good use.

I also attended the Vancouver Regional Office Seasonal Open House, which was a good opportunity to meet members in a more casual atmosphere.

My local continues to struggle with the employer on a number of workload issues, but I think they found out just how united we can be when we were able to get over 50 members to sign a grievance over changes to the already miserly Christmas

Bonus, which meant even less money for people who are already struggling to make ends meet in such an expensive province.

There have been some challenges though. Conflicting times for meetings have forced me to choose which committee to participate in. This year at work seemed to be a particularly heavy peak season, leading to me having to miss events that I would have liked to participate in. And the fallout from such a busy peak season left my health vulnerable. In particular, I would have liked to be able to attend the December 6th Vigil, the Water Ceremony in Victoria, the Metro Vancouver Alliance Fare Review Listening Session and the January 20th Women's March.

Committee work continues. DASH approved a number of donation and subsidy requests, and I will be looking at getting some information out to committee members about awards that we could look at adding to the Region in the future, hopefully for discussion at the in-person meeting. By-laws has started looking at Area Council Bylaws for consistency. Thanks to Trish for getting the links out to us to start looking at.

Upcoming for me are: my first bargaining session, possibly in March; the Vancouver Area Council AGM.; the Mainland Human Rights Committee AGM; and Canada Post Ratification meetings. I'm hoping to be able to work with the other Metro Vancouver Coordinators on figuring out worksite visits and actions that we can take to get members more engaged.

November 2017 to January 2018

- 1. November 3-5, 2017 Attended BC Regional Council Meeting in Vancouver. In addition to regular BC Regional Committee Agenda items, we had the opportunity to learn the roles and responsibilities of BC Region PSAC staff and the ways in which we may engage them to assist in our local events and actions. I was also assigned to the following committees:
 - By-laws Committee I chose to participate in the Bylaws Committee as I need to gain experience in this area. I would like to do my best to ensure our Northwest Area Council is set up for success. I hope to learn from those more experienced in relation to their work with bylaws. Also, our NW Area Council bylaws need to be updated to ensure consistency with the PSAC constitution. We, as the Regional Bylaws Committee, agreed to review bylaws of all the BC Area Councils and to make recommendations for changes.
 - Environment Committee I do have a passion for the environment. Our environment committee is working on a couple of resolutions; one in relation to plastic and one in relation to solidarity with those standing up for environmental protection. Our environment committee discussed having a teleconference on February 18, 2018 to further discuss our considerations.











- **2.** November **16, 2017** Attended teleconference to discuss ongoing and upcoming Phoenix actions and issues. I shared our plans for the December Prince Rupert Phoenix action.
- 3. November 7 to 26, 2017 Affordable Housing / Poverty From November 8 to 26, I actively advocated for and supported the homeless of Prince Rupert in the creation of a Tent City. With housing costs rising, our homeless numbers have been increasing. Prince Rupert did not have a shelter for the homeless. This was completely unacceptable and especially so, given that we very often have inclement weather on the north coast. On Nov. 7, a very beautiful young lady named Patrika, advised me that she will be working with the homeless to erect a Tent City at Prince Rupert City Hall, as she feared for their safety over the coming winter months. From the inception of Tent City on November 8, to its dismantling on November 26, I supported Patrika in her efforts and the homeless in any way I could. As I was able, I personally provided

food and materials to Tent City and its residents. We started a Facebook Page and sold buttons "Prince Rupert Cares – Homes for Everyone". We advocated for political and community support. I participated in a 'homelessness' tour. I pledged Patrika in a Homelessness Challenge, where challengers were to spend 24 hours homeless. I attended a city council meeting, and immediately after Tent City was erected provincial and municipal officials began to do more than talk of homelessness in Prince Rupert; they took some action. On November 14, Jennifer Rice announced there will be 44 supportive housing units coming to Prince Rupert in 2018 and that there will be 12-hr emergency shelter once space is found. My support and advocacy toward this issue will continue until there are "Homes for Everyone" 24 hours per day. I was very honoured to work alongside Patrika in these actions. She took the courageous first step of erecting the tents. She very successfully started a fire and kept it burning. Her actions and communications were instrumental in leading to the announcement by city and provincial officials that funding has been found for our homeless in Prince Rupert. I look forward to the day when our Northwest Area Council has finances transferred back from region so that I may approach them for small bits of funding for worthy initiatives such as this.

- 4. November 22, 2017 Missing and Murdered Indigenous Women (MMIW) Community Event Caribou Legs On November 22, I had the opportunity and honor to meet Caribou Legs, a #WarriorAgainstViolence. He stopped at our community on his Highway of Tears Healing Run from the Lheidli T'enneh territory (Prince George) to Tsimshian territory (Prince Rupert). Our community shared a meal, song, and dance. He shared his experiences in relation to MMIW and domestic violence. He explained how #CultureSavesLives and shared "Caribou Legs The Film," a movie produced to raise awareness of MMIW and domestic violence.
- 5. November 29, 2017 to December 4, 2017 National Leadership Conference Ottawa. I had the opportunity to attend the National Leadership Conference in Ottawa. My favorite course at the conference was "Creating a Communications Strategy for Effective Membership Engagement." I look forward to putting this learning into practice in my plans for engagement with members of the Northwest.
- **6.** November **30, 2017** MP Lobbying Phoenix Pay Nathan Cullen On November **30, 2017**, Sky Belt, Jamey Mills, and I took our concerns with Phoenix to Nathan Cullen. We told Nathan about the impact Phoenix is having on the personal lives of our workers.
- 7. December 1, 2017 Joint Learning Program (JLP) Focus Group On December 1, 2017, I volunteered to attend a JLP focus group to provide feedback in relation to the benefits and challenges of the JLP process.





- **8. December 3, 2017 Phoenix Christmas Carols on Parliament Hill** On December 3, 2017, I joined our sisters from CEIU who organized a Christmas Carol session on Parliament Hill. We sang a few different songs explaining our frustration with the Phoenix Pay System to the tune of Christmas carols, while affected members shared their pay problems with media.
- **9.** December 15, 2017 Phoenix Pay Action Christmas Gift to Trudeau | Organized a Phoenix Pay action in Prince Rupert. December 15, I invited Northwest PSAC members to join me for coffee and muffins and to place a card in our gift and letter to Justin Trudeau.

As such, enclosed you will find your holiday gift from us -- a lump of coal -- straight from Prince Rupert's Ridley Coal Terminal, and some cards signed by members (it is unfortunate that you will note many are angry).

PSAC members here are saddened that laws governing the pay of federal workers are being grossly ignored. Many here are not being compensated accurately or on time for now going on two years. If you hope that federal departments have the ability to deliver quality public services, we feel running a country with such negligence is not the answer. We do not want to spend our days figuring out how to get this fixed in a system that is not working. We do not want to spend our days filing grievances or being sick and stressed because of the pay system.

The situation is a mess, but we have hope! We can fix this! With your gift of coal, I have enclosed some tools to help us – some pencils, an eraser for really BIG mistakes, and a calculator. Perhaps we can utilize some of the brilliant employees here in the Northwest. We do have one employee who used to be a pay specialist; she was given the pink slip by the previous government then transferred to a new job in our area. She is quite awesome by the way. She has spent many hours working with affected employees figuring out the accurate amount of pay they are due. She has the skills and the know-how. What she is lacking is the government priority, the system, and the authority to pay employees properly.

I really hope your name can be struck from our naughty list. Until the pay situation is straightened out, we ask that you adhere to the attached 5 demands. I have enclosed my card if you would like to contact me to arrange a meeting. Together with the pencils, erasers, and the calculator, we can help you get this fixed.

The rally was well attended by approximately 75 members from PSAC, PIPSC, and some Unifor members. Members were interviewed by Chek TV, and I was honoured to be on CFAX and CBC doing live interviews. The rally was aimed to bring awareness to the public about our pay issues.

In November I attended the UNDE bargaining conference. I was elected to represent UNDE for the PSAC bargaining conference to take place in March of 2018. This experience gave me the ability to witness the demands of UNDE members across Canada. I was pleased to see there was many similarities in our proposals.

On November 23rd, I attended via conference call the VIHRC AGM. The committee elected a new executive and I have reached out to those executive members to see how I can better support the Human Rights committee on the Island and assist them in making the committee more active.

On November 29 through December 3, I attended MP lobbying and the PSAC leadership conference in Ottawa. We met with MP Randall Garrison and were invited to a meeting for the defence critics with the Minister of Defence Harjit Sajan. During the question period, Randall Garrison spoke about the Phoenix Pay System and the members of his riding facing pay problems listing specific examples. We were given a promise that the Minister's office would contact us directly to assist in fixing our pay problems. I left that meeting feeling positive that we had a contact through Jody Thomas to be able to push some of the cases we face at DND to be rectified for the members. We continued to wait...

The PSAC leadership conference was attended by approximately 300 members. There was a wide range of speakers and panelists as well as individual workshops. One of the things I took home with me was the type of leader I am as well as other members I have worked with in the past.

During the conference, we also took the opportunity to meet as a group for the PSAC BC Political Action Committee. We spoke about Phoenix and brainstormed ideas for future actions and rallies, etc. The challenges some smaller areas face is the magnitude of the action needed to make an impact. We discussed options for those members.

As the one of the South Vancouver Island Coordinators, I took the liberty of taking a donation collection for a long time staff member Dave Jackson. Dave, who retired on January 13th, was a huge support for many of us on the Island: he was a mentor, a teacher and a leader. Dave was presented his gift shortly after his retirement. He was quite touched by the gesture and generosity of the Island Locals.

On December 18th, I attended the BC Regional Council Teleconference call.

From December 22 through January 8th, I was on holidays.

On January 10th, I attended the Victoria Area Council meeting. We spoke of the upcoming National Day of Action for Phoenix in February and the interest of the Components to participate, ideas etc. We went through the schedule of events for the year for the Area Council and had two speakers at the meeting. It was progressive.

On January 16th, I had a follow-up meeting with MP Randall Garrison. Randall was disappointed to hear we had not received any follow-up from our November meeting with the Minister of Defence, and Randall said he would raise the matter in Question Period. I have continued to work with Randall, and we have discussed a collaborative, joint project of Phoenix pay cases and public awareness. Randall was seeking stories of constituents from his riding to share their stories with the local newspaper. He felt that by doing so it would give the local public the understanding that this is going on in their community. We have been successful at having members share their stories. We would like to continue receiving more cases to be published.

On January 31, I attended the Victoria Regional Women's Committee AGM. My goal and focus of this term is to increase and better assist the committees on the Island with participation and interest. As the committee was unable to hold the December 6th event on the Island due to lack of participation, I felt the need to assist in revitalizing the committee. I was honoured to be voted in as the chair. I look forward to working with everyone.

Over 2000 people attended the March ON Event that took place in Vancouver to END Discrimination of all intersections and advocate for total equality.

Resistance and activism is up across North America, expanding this year with #MeToo and the anti-trump, anti-white nationalism movements which all started at a grassroots level.

People are talking about minimum wage, gender equality in the workplace, and status of sex workers, affordable child care, women with disabilities, sexual violence against domestic workers, and missing and murdered indigenous women.

The march was attended by anyone and everyone who supports the values of equality, inclusion and intersectionality.

Speakers included:

- Child Care Advocates; Islamophobia Advocate, Noor Fadel. Noor was assaulted on the Skytrain Canada line last December for being Muslim, she performed a poem about her thoughts on the attack.
- Wage disparity
- Black Lives Matter Vancouver speaker, Judi Lewinson discussed the Hogan's Alley as the site of the former thriving Black Community and its rebuilding in the future.

This year, organizers stressed an importance on race, class and sexual orientation to reflect increased intersectionality.

Speaker Hailey Heartless recounted how she did not feel comfortable attending the march last year as a Trans woman and a sex worker, as well as the hate she received for being announced as a speaker this year.

"Stigma is weaponized to keep us out of feminist spaces," said Heartless. "[Sex workers] are not victims ... Sex work is real work — we face stigma when outsiders call us prostitutes ... and we face stigma from laws that take away our agency."

Vancouver #MeToo rally draws dozens in support of sexual assault survivors

Sexual and other types of violence against women were discussed by many speakers.

Angela Marie MacDougall, the executive director of Battered Women's Support Services, said her organization responds to 11,000 cases of violence against women annually. The message focused on collectively addressing violence against women as we strive toward equality.

Indigenous speaker Lorelei Williams told stories of missing and murdered Indigenous women, including those of her own family members' loss and survival.

I went to the Victoria Pride Society's AGM. It was great seeing so many diverse people from the community. I also went to see if they have this year's entry fees available. They aren't available yet but will be available in the next month or two.	It fulfills my role on the regional council as it gets my face and name out there as a labour activist in Victoria Queer community. It is also important to learn about the costs of entry fees. Through protests and collective action, the private and individual queer experience of discrimination is given a very necessary public stage when the Union partakes in Pride Parades.
I aided a Trans Member in Victoria who is facing micro aggressions and being misgendered on a daily basis at her work place. I helped them understand their rights under their component's collective agreement to be provided a work place free of discrimination. I also provided them with a copy of the Support for trans employees: A guide for employees and managers created by Public Service and Procurement Canada. As of the writing of this report I am still trying to do a lunch and learn on Trans issues for the members of their work place.	My role is fulfilled by standing up for LGBTQ+ members. Transgender workers do not expect any special treatment. They simply want their identity to be respected. This often means they want to be addressed by the name and pronoun that reflects their gender identity. Most often transgender members want to be referred to with the pronouns "she" "her", "he" "him" or "they" them". So education on what pronoun to use and LGBTQ+ issues are so important. Also, just like all coworkers, LGBTQ+ members do not want other members and the employer talking about them behind their backs or making fun of them. I believe education is the best way to combat misunderstanding and to end homophobia and transphobia.
I spoke with Sylvie Berube ADM for Employment and Social Development Canada about three Transgender issues.	It is always important to engage the Employer's Leadership to help create change and a supportive environment. As the Pride coordinator it is fulfilling to stand up for the LGBTQ+ members for BC.

Three Issues discussed with ADM Sylvie Berubes

1. There are no gender neutral washrooms in my work place. A comfortable place to go to the washroom in mid transition is so important. I am wondering if the Government will be making gender neutral bathrooms available and mandatory in all Government buildings? I am not asking for every bathroom to be gender neutral I am just looking to have one washroom in every work place designated as gender neutral.

Sylvie Berube's response was that the Employer is going to reach out to Public Services and Procurement Canada (PSPC) to inquire on how the issue is being addressed in the government infrastructure. The Employer will put forward for further discussion and consultation to develop & implement a consistent strategy across the Department. She believes it is important to have meaningful engagement and consultation with members of the transgender community to develop next steps, refresh the Interior Design Standard (IDS) and implement an approach. To engage the transgender community, we will reach out via the various network contacts such as the Pride Network to engage in the upcoming work necessary to address the needs of our LGBTQ2 employees and clients.

2. Is Service Canada going to adopt the Support for Trans Employees: A Guide for employees and managers, which was developed by Public Workers and Procurement Canada or is Service Canada going to create their own document? If you are creating your own document, it is important to get input from members of the transgender community.

Sylvie Berubes response is that at this time there is no national guide for Trans employees and clients. She states that National Headquarters and the Pride Network Co-chairs have been engaged in the process to ensure that a meaningful guide is created.

3. Can there be some training implemented for the phone unit and in-person staff on how to deal with transgender client who are in mid transition and haven't legally changed their gender and name? For security reasons I understand that we have to ask for the person's legal name however for many they have changed their name in their personal life before legally doing it and prefer to go by a different pronoun. I would like to see training on how to address someone who is in mid-transition and how you address someone once they have passed the security questions. I would be happy to create a training package and help implement and teach it.

Sylvie Berube response Service Canada has recently implemented mandatory training for all employees in the form of the Richness of Our Differences online learning course. She states this course is designed to help employees understand the importance of being part of a diversified workforce. The course materials

include specific information about the LGBTQ2 community. As well she says ESDC has also committed to training Positive Space Ambassadors across the country and has certified over 400 this year. There is a continued commitment to train a further 400+ Ambassadors by 2018/2019. Additionally, In-Person Services has engaged the Service Canada College to develop training on how to serve clients who are in transition. This request is very early stages of development at this time, however, this product, once ready, should be easily adaptable for other business lines to use.

Challenges you had to cope with since the last meeting:

Not enough time to devout to my various endeavours.

What would you like to work on next?

 I would like to create a living tree LGBTQ+ glossary designed to provide basic definitions of words and phrases commonly used. All language is constantly evolving; new terms are introduced, while others fade from use or change their meaning over time and it would be nice to have a record of this at regional offices and for components on request.
