# Component Check-In:

Ben Scraff-USGE:

Ben explained that there are 12 unionized employees in his office and everyone gets along, but that the ER in the lower mainland is trying to lower the workload of each FTE in order to lower the number of FTE's required. The Union members in the lower mainland have opposed this action.

### Kim Koch-UTE:

Kim explained how the TSO in Prince George has merged with the Burnaby Fraser office and the challenges this is cause the members here in Prince George. She also

explained the frustration the members feeling with the stall of the Bargaining between UTE and CRA.

## Fortune Peranio:

Fortune updated that Purolator has just signed their contract and morale is good in the office.

### Sharon Tucker-USG:

As of last week there are 48 affected in the Surrey office. The CR 4's and 5's are going to be starting negotiations shortly and it's going to be a fight. The members are showing signs of division. The older members don't want to fight it and the younger members want to fight for the benefits.

### Collette Green-CEIU:

The Prince George office has gone from 127 FTE's to 27, the morale is bad. Their contract is up in June and the fight for a fair contact is going to be ugly.
