# Report of National Officer Representative PSAC BC Regional Council September, 2011 Nic Humphreys

I would like to start off this report thanking all the national officers for allowing me to continue as their representative on the BC PSAC Regional Council. In August the UEW members from BC/Yukon also gave me the honor of acclamation for the RVP position.

This report covers most of my activities since my last report in March 2011. I have only included those that are directly or indirectly related to my position on the BC regional council. I have been elected to the executive of the Victoria Labour Council and in that role I chair the political action committee and act as the liaison between the council and the provincial and federal NDP riding associations. Until our meeting of the regional council in October I am the chair of the regional council *political action* committee, co-chair of the *finance committee*, sit on the BCFed *climate change committee* and sometime on the BCFed *political action committee*.

#### Harper Attacks on Public Service

It didn't take long for Harper's agenda to be apparent at least in the departments that I represent. Over 700 federal government workers given WFA letters at Environment Canada, programs cut and environmental services cut. At Fisheries and Oceans 86 million in cuts, closing of search and rescue centers and more WFA. The PSAC has started a fight back campaign, which I encourage every component to get involved in.

It was the WFA letters that were received by my members that prompted me to send an email out to the national officers more than 3 weeks ago concerning WFA. I also asked that the national officers either contact me or the regional office about education requirements for locals on WFA.

We, Bob Jackson REVP, Joanna Schultz regional coordinator PSAC and I have been discussing the need for a conference call with the national officers in September to plan a national officers meeting for the early fall. The focus of the meeting would be:

- 1) Educating the national officers around WFA.
- 2) How best to deliver that education to the membership.

I will be in touch with the national officers hopefully the first or second wee in September about scheduling a conference call.

#### **Bargaining**

Bargaining is a never ending process within the PSAC. At Treasury board we have the TC and FB groups at the table. At the separate employer table we have Parks Canada and CFIA is barging with the Agency. I had the opportunity on Sept. 1 to meet with the Gail Lem negotiator with the TC group as Gail was out on Vancouver Island meeting with the TC members at their worksites. Gail updated Victoria area activists on TC negotiations at a special meeting at the regional office. Negotiations are moving slowly and of course TB has so far offered little and is asking for concessions. Bargaining will not be easy this round for any of our groups but a dedicated team back by engaged members should be able to achieve an agreement that we find acceptable.

#### Health and Safety Forum

This is a reminder that the PSAC has issued an invitation to the 2011 PSAC National Health and Safety Forum which will be held in Ottawa November 22-23, 2011. I expect that I will see a number of the national officers from BC at the event.

The deadline for receipt of names of members interested in participating is **October 7**, **2011**.

#### Federal Lab Privatization

At the last PSAC convention a resolution was passed to build a campaign to fight Federal Lab Privatization. National officers have been encouraged to ask their members to come forward with statements from their members that outline the work they do within Federal labs and the overall work that is accomplished within Federal labs. Information that has been sent to me has been forwarded to the PSAC.

#### Component/PSAC Campaigns

The components and the PSAC have at any given time several campaigns on the go. The lobby efforts continue on behalf of the membership, through the CLC and the Victoria Labour Council, the Victoria Area Council and the PSAC. National officers that have campaigns of campaign idea's that they want to share or need assistance on please let me know and I will bring these forward to the regional council.
