# November 19, 2014 Re: Request for funding to attend 2015 PSAC National Convention as an Observer

Dear Committee Members:

As an active PSAC (Agriculture Union Local 20044) member I am writing to request funding to attend the 2015 PSAC National Convention as an observer.

Attending the convention as an observer would be a great opportunity to witness the resolutions we passed at the regional convention be discussed on the floor, network with other activists, and learn from the amazing people that will be there. I feel this experience will better equip me to engage and mobilize our members as I will be a better resource for information on the democratic process of our union.

*I would like to request \$300 in funding from the Vancouver and District Area Council for attendance as an observer to the 2015 national convention.*

### Introduction of Guest – Karen Hall from PIPSC

Karen was given an opportunity to speak at the opening of the meeting. She talked about her position in PIPSC within her local and the solidarity activities that she and Cheryl Oenema have been putting on at their worksite. Thanked us for the opportunity to attend the VAC Meeting.

### **Election Info:**

Jamey introduced Patrick.

Patrick spoke about the CLC Document "Federal Political Party Financing Rules, Third Party Advertising, Voter Contact and the Labour Movement" FAQ, which outlines changes that came about under Bill C-24 (*An Act to Amend the Canada Elections Act and the Income Tax Act (political financing)*). Patrick highlighted the FAQs that most directly affect the Vancouver Area Council and the political activities that we engage in as union members, including contributions to campaigns, paying for attendance at political fundraising dinners, advertising and what records we need to keep when making calls to our members around election issues.

Patrick also spoke about the upcoming CLC Election Preparedness Conferences.

## Nanaimo March 6-7, Vancouver March 13-14

These conferences will offer skills training and networking opportunities in the wider labour movement. The Vancouver event is being held at the Vancouver Coast Plaza Hotel. Will be 2 hours on Friday night, 7-9pm with a plenary session and reception afterwards. Saturday will be skills building workshops, participants can chose 2 of 6 workshops on offer. These include "Face to Face Skills in the Workplace and Community", "Effective Campaigning", "Basic Campaigning", "From Engagement to Action", "The Importance of Niche or Local Ethnic Media" and "Delivering Messages that Work".

There is full funding for three members of this Council to attend but we are also willing to partially fund if anyone else is interested in attending. Crystal also mentioned that for CEIU members there would be some funding available. Jamey opened the floor to ask who would like to attend, it unfortunately falls on the same date as the PSAC Convention Delegates pre-convention Caucus meeting, so delegates to convention will not be able to go.

Todd Smith, Cheryl Oenema and Sharon Tieman committed to go. Kelly Sidhu, Mandy Chahal and Ruby Langan also expressed interest. Patrick gave them registration information.

Jamey spoke to the importance of the the upcoming Federal Election. It is the election of elections, specifically and especially for public service employees, you are voting in your employer. We all as an Area Council need to engage our members and be prepared to give up some of personal time to phone banks. We are not sure if the election will be called early, signs are starting to point to no, but we need to be prepared that it can and will happen at any time. It is scary to put yourself out there and cold call our members, but we will have decent food and you'll have the support of your fellow union members, the phone banks will be at the Regional Office.

## Action Item:

Car Free Day – Main Street or Commercial Drive, falls on Father's Day – Jen (not primary) – Jamey will ask Terri if she would be willing to take this on again

Aboriginal Day – Ruby, Crystal, Cheryl

Canada Day – July 1<sup>st</sup> – or maybe attend Golden Spike Day – Crystal (if we do this event)

Pride – Sunday of the August long weekend – Todd, Mandy, Crystal

Labour Day - Crystal, Patrick, Sharon, Jen

Area Council BBQ – maybe make this a joint event with PIPSC, hold in August or early September – Jamey, Jen, Todd, Sharon (if it is in September)

Jamey opened the floor for suggestions for other member/public engagement events that we could participate in or put on. Todd suggested a Curling event in the winter or possibly a Bowling event later in the year, Jamey added that we could possibly make it a fundraiser for the MVA.

Crystal mentioned that CEIU was participating in the Labour Walk with Joey Hartman of the VDLC at 4:00 on February 27, invited VAC members to join in.

Crystal suggested that part of the budget for any event we participate in should be to provide for lunch, parking and childcare if needed for volunteers at events.

Sandra Wasilewski puts forward a motion requesting funding of \$300.00 to attend the CLC Winter School at Harrison Hot Springs to take Union Counselling Level 1. (M/S/C) Jamey/Crystal

## Local Reports:

Cheryl Oenema (UCTE 20219) - AGM held in November. President and Vice President were acclaimed. Some new members on the executive.

JLP session held Jan 8/15. Understanding the Collective Agreement. Well attended, had a wait list will be scheduling another season.

Held a union solidarity event at Transports 800 Burrard location. Initiated by PIPSC. Organized by PIPSC, PSAC (UCTE, GSU, CEIU) and CAPE, with members from Transport Canada, PWGSC, CIC and Shared Services. Held on Dec 23rd at first coffee break. Really well attended, lots of great feed back. Had about 140 people. Looking to do another event in a he near future.

Jennifer Horsley (UPCE 20095) – attempted to hold AGM in November, poorly attended, did not make quorum, so we will be trying again on January 25. We have decided to bring in members from outside of the lower mainland (which will allow us to make quorum) and have rented a meeting room at the Radisson in Richmond. We are losing 3 clerical positions in our Sales department in Richmond, all of which are held by high seniority members, so there will be some bumping, and we are looking at possibly losing more positions in the spring.

Jamey Mills (UTE 20027)

-PIC completed. We are happy the recommendation was for a contract of more than 2 years. Bargaining resumes shortly.

-office is being relocated Jan 2017 to consolidate several locations. Main and Terminal in office to be built. -AGM will be held 05FEB15

-ongoing plantgates to educate members on bargaining and importance of paid sick leave

### **Education:**

The education schedule for the spring is out. Please advertise this to your members, mostly basic courses on offer because of all of the advanced courses that were offered in the fall and because the activist school at the end of the month is taking up a lot of resources.

## **MVA Transit Meetings:**

It's time to hold the politician's feet to the fire and hold them to their promises around the Transit Referendum. The MVA is holding events in New Westminster and North Vancouver. New West is January 27<sup>th</sup> and North Vancouver is February 3. Please see their website for more details.

## **February Meeting:**

We need to hold a meeting in February because of changes to the PSAC Constitution which came out of last convention that changed the Fiscal Year End. We need to make by-law changes so that we can come into line with these constitutional changes so that our fiscal year would run from January to December. In preparation for this meeting we will need to have the expenses prepared and audited from October to December 2014. Jamey asked for volunteers from members in good standing– Kelly and Cheryl will audit.
