2) By law changes (Jill MacNeill)

Jill advised that she wanted to give notice that we would be discussing wording changes for quorum at the November 4, 2019 Area Council Meeting – the current wording is as follows:

Section IV – Meetings Subsection 2 – Quorum shall be the majority of the officers and 10% of the Locals, Branches, Directly Chartered Locals and Regional Committees

The new wording proposed is:

Section IV Subsection 2 – Quorum shall be two officers and three Component, Branch, or Directly Chartered Local Representatives These proposed changes will be discussed at the next Area Council Meeting on November 9, 2019.

3) Update on Burnt by Phoenix tee-shirts (Jill MacNeill)

A discussion was had regarding purchasing Burnt by Phoenix tee shirts and how many we could afford to purchase.

At the moment, we are unsure of the number of people from the various locals would want/wear the tee-shirts.

Nicole Pottle offered to make an order form for the shirts that the Area Council could distribute to the locals to see what kind of interest there was and what kind of budget we would need to order shirts for those who wanted them. Discussion was had around having individuals pay for part of the cost and the Area Council paying for the rest, within budget.

At the meeting on November 9, 2019, we will be discussing the resolutions that we would like to bring forward to the Regional Convention. Some of the proposed resolutions revolve around climate change.

Reminder that resolutions to Convention must be in by December 31, 2019

6) Grievance Handling training:

Jennifer enquired about the possibility of having grievance handling training in the spring. Deanna suggested that if people wanted to attend as a group, they could put forward a list of potential workable dates to their Regional Representative. Deanna has now accepted a position as the Regional Education Officer and so a new Regional Representative will be appointed shortly.
