# REPORT OF THE REGIONAL EXECUTIVE VICE-PRESIDENT TO THE BC REGIONAL COUNCIL May 2012 through October 2012

#### **Political Action**

#### "We Are All Affected" Campaign

The "We Are All Affected" (WAAA) campaign was a primary focus for the BC Region this summer. Kicking off in late June, and building on the work of the "Standing Up for Public Services" activities, this campaign allowed us to show our collective support for those members and their families who have received affected letters. At the same time, this campaign has enabled us to continue voicing the value of federal public services provided by our members for all Canadians.

As part of the WAAA campaign, our Region engaged the public through a variety of public events. Area Councils and BC Regional Council members took the lead on organizing booths and participation at various community events, including the Surrey Fusion Festival; Pride activities in New Westminster, Vancouver, Victoria and Surrey; the Cumberland Miners' Memorial Weekend; Nanaimo's Bathtub Festival; 'Justice Rocks' and Terrace River Days; Labour Day picnics throughout the Region, to name a few. I must acknowledge the hard work and time that members contributed to these events, without which they would not have been successful.

On September 15th, the PSAC held another National Day of Action in tandem with the WAAA campaign. Members from every Region were invited to attend events and rallies organized to speak out against the federal service cuts. In BC, events took place throughout the Region and provided the majority of members with an opportunity to participate.

Along with our campaign, the public and community groups have engaged around the closure of the closure of the Kitsilano Coast Guard Station in Vancouver. The proposed closure of the facility has been met with some of the most vigorous opposition we have seen to date. Earlier this summer, I attended several meetings and rallies regarding this closure. At each one of them, the Conservatives have refused to attend. These meetings and rallies culminated in our 24-hour occupation of the station on September 14-15, 2012. Together with elected officials of the BC Federation of Labour, UCTE, boaters, and other stakeholders, we occupied the station with the aim to gain the attention and acknowledgement from the Federal Government regarding our position on the closure.

Even in advance of the occupation, there has been fantastic support for our bid to keep the Kits Coast Guard open from the opposition, provincial and municipal levels of government, as well as many concerned citizens and continues to be so despite little response from the

Harper Government. I would like to acknowledge the hard ward of UCTE, and in particular Dave Clark, the National Officer responsible for the Region. We are not easing up on the Federal Government, and we are confident that they will have to back down in the face of the tremendous pressure we have applied. This is a fine example of groups of concerned Canadians fighting back against idiotic decisions of a government bent on destroying our country as we have come to know it. It has been made very clear in this fight that this Government does not have a mandate to put lives at risk as a result of ill-conceived decisions.

My thanks goes out to all the members who have volunteered their time and energy to National Day of Action and to the WAAA campaign. I'd also like to encourage those members and other to continue this important work over the next few months. It is now more important than ever to continue the work of the campaign and communicate the message that we are, in fact, all affected: every member, every family, every Canadian.

The National Day of Action was not planned as the acme of the campaign, but rather another stage in our ongoing battle to defeat the Harper Government. Together we have built alliances in communities within the Region and across the country to demonstrate that cuts to public service workers and the jobs that they perform affect all Canadians and these cuts cannot be tolerated.

The next funding phase of the WAAA campaign is slated to roll out in January 2013. Before then I am encouraging members to identify activities and/or events that can be used to promote and communicate the campaign to the public. As always, I welcome the suggestions or Regional Council and other PSAC members.

#### **Harper Hates Me Buttons**

Even before we had them in our hands, the "Harper Hates Me" buttons were a hot commodity in the Region with both the Vancouver and Victoria the Regional Offices receiving a number of calls from both members and the general public with requests for them.

We have been handing out the "Harper Hates" buttons along with WAAA campaign materials at our campaign events – the different variations, including "Harper Hates ... Us, the Arts, the Environment, Health Care, Food Safety, Canada", are resonating with the public, many of whom I'm sure are still wearing the buttons today.

While the public has been in favour of the "Harper Hates" buttons, the employer doesn't appear to be. The employer considers the wearing of these buttons in the workplace to be in violation of various values and ethics codes in force across the public service and within various departments. As such, the employer has gone as far as to request that the National President

put out a message to all members discouraging us from wearing the Harper Hates buttons in the workplace. Sister Robyn Benson has not done this, but she has reminded members of the general approach to situations such as these: obey first, grieve later. This situation is somewhat different with regard to wearing the buttons outside of the workplace, but it too carries risk for members. The PSEA allows anyone to file a complaint against a public service worker for improper political activity. The extent to which an individual public service worker can be politically active depends on many factors, including the worker's visibility and duties. That said, because political activities are regulated by the PSC, there is a risk of investigation and non-adjudicable discipline if the PSC receives an allegation of improper political activity against one of our members. So a word of caution is directed to all members on this matter and I would encourage RC members to refer to the guidelines on speaking out as sent out by the Executive Branch in early July.

#### **PSAC BC Commissioned Public Survey on the Federal Cuts**

In tandem with the WAAA campaign, in July the PSAC BC Region commissioned an online survey by Stratcom Strategic Communications, a full service opinion research and communications firm. The survey polled 1035 British Columbian adults on their opinions of the cuts to public services, asking six questions on specific public services affected by the government's plan to reduce spending by a cumulative \$5.2 billion per year.

The results of the survey overwhelming show that a clear majority of British Columbians across all demographics strongly opposed the cuts. This information will be incredibly useful as we continue with the WAAA campaign. Some of these statistics were released following the National Day of Action, garnering some media attention. Over the coming months we will continue to use these statistics to demonstrate the lack of support that Harper's austerity measures have with Canadians.

#### **NPSW Boycott**

Shortly before our WAAA summer campaign kicked off, the employer hosted its National Public Services Week under the ironic theme "Celebrating our Commitment." This week of so-called celebration was amidst thousands of members being handed their affected notices. As a result of this oblivious and audacious behaviour on the part of the employer, PSAC members agreed to boycott NPSW activities and/or hold their own.

In BC this ranged from delivering official statements of non-participation to the employer to the cancellation of employer-organized BBQs and lunches to quasi-picket lines being erected in front of employer functions. In Victoria, UTE held a softball tournament for members, providing food and prizes. I also attended this event and found that many members had used their own vacation time to participate in the event as the tournament was in no way endorsed by the employer.

No matter the level of participation in our own PSAC NPSW activities, the message to the employer was clear from our members: "there's no celebration without the services and the people who provide them."

#### Visibility in the workplace and community

My commitment to making the PSAC more visible, both in our members' worksites and communities throughout the Region, continues with several worksite tours, meetings and visits over the summer months. I was able to visit the BC Southern Interior, including stops in Kamloops, Revelstoke, Cranbrook, Nelson, and Trail. Some of these areas I didn't have the privilege of visiting in my first year as REVP; I am pleased that I have now been able to meet with members face-to-face in this constituency. During this trip I had the opportunity to visit all CBSA Border Crossings in the area and meet with BSOs and admin. As I've commented before, my travel allows me to meet with members and discuss the impact of the job cuts and other issues relevant to their worksites.

During my stay in the area, we also held a meeting in Kamloops to gauge the desire to form an Area Council for the members located there. Overall, the feedback was positive and we will continue to work to achieve this goal over the coming months.

In June I also traveled to Tofino on Vancouver Island. The purpose of this trip was two-fold: to visit with members and to meet with the Tofino Chamber of Commerce regarding the Parks cuts to the Coast Guard in the Tofino-Ucluelet area. Together the Mayor and I spoke to media about the potentially dire and deadly implications that could result once the closure of the Coast Guard Marine Communications & Traffic Services centre is actuated and the Surf Guard Program is discontinued in Long Beach.

More recently, I traveled to the Okanagan area a couple times for worksite visits. My visit to the area with Martha Johnson allowed us to connect with members in isolated worksites who do not hear from the Union very often. My hope is that these visits will provide members with an opportunity and the tools to engage in the Union and with the work before us.

As I've mentioned in the past, PSAC visibility in the workplace and in the community is very important to our overall effectiveness. It is through actions such as those listed above that we are able to build solidarity and support for our affected members facing job losses and contribute to the public awareness of the negative impact federal cuts will have on all Canadians.

#### **BC Provincial Election**

With less than eight months until the BC voters head to the polls, candidates are already hosting fund raising events and dinners to prepare for their campaigns. As such, the PSAC BC Regional Council has sponsored a number of tickets to BC NDP events over the last few of months, allowing members to attend and provide their support to the Party. I've also had the opportunity to attend a couple of these fund raisers. I can attest that the energy is high and the election outlook is very promising for our friends in the BC NDP. It appears that BC voters are just fed up with the BC Liberals and aren't going to change their minds in the absence of extraordinary circumstances.

In addition to our attendance at fundraising events, we will be calling on members to assist with the pre-election campaign efforts in targeted ridings this winter and spring. We will need volunteers to go into these ridings to lend their support and time on the phone and through a variety of activities. As we saw with the recent provincial By-elections, having members volunteer their time these kinds of ridings makes a significant impact on the election outcomes. We were quite successful with the By-elections, and we hope to be so again this May.

#### NDP Public Consultation Meeting on Bill C-38 (Omnibus Bill)

In May, I attended the NDP budget consultation in Vancouver. The theme of the consultation was government transparency, accountability and ethics. The objective was to pressure the Federal Government to break up bill C-38, the nefarious Omnibus budget bill, and create public awareness on the Bill. The event was extremely well attended, with standing room only.

Regrettably, as we all know, the Omnibus bill did eventually go through the House; nonetheless, public opinion was generally onside with our views against lumping so much legislation into a single bill and forcing it through Parliament.

#### **BCFL Teamsters Rallies**

On May 29th the BC Federation of Labour organized an emergency rally in Vancouver to protest against a bill that would force Canadian Pacific workers back to work. I attended the rally and was asked to speak on behalf of the PSAC. I spoke out against the Harper government's attempt to (yet again) legislate Collective Bargaining rights away. The crowd, including a large and varied spectrum the Labour community, echoed our message, "Say 'No' to Harper."

Just a month later, the BC Federation of Labour held another Vancouver rally in support of another Teamsters Local. The June 22nd rally marked the one year anniversary since the lockout began for Local 31 at Rocky Mountaineer. Three months later, I'm happy to report that the 15-month lockout ended when Local 31 ratified a new Collective Agreement in this past September.

#### **XL Foods Beef Recall**

In September a massive recall of beef products was announced due to E. coli contamination at the XL Foods Ltd. in Brooks, Alberta. This recall confirmed our concern about cuts to the CFIA. The XL Foods voluntary recall is the perfect example of why we need to keep and strengthen food inspection, and the public need to be aware of this. During the recall, the PSAC, nationally and regionally, engaged the media to discuss the situation and bring to light our concerns on the connection between the cuts and the recall. Personally, I took a number of interview requests from media to discuss the recall over the course of September and October. My hope is that Canadians will understand that there can and will be serious and potentially lifethreatening consequences that result from Harper's austerity measures.

#### **Health and Safety**

As you will likely be aware, Health & Safety has played a large part in my entire work life. So it will come as no surprise that I have fully embraced my assignment of the Health & Safety portfolio for the AEC. I have already been hard at work focusing on promoting OH&S in the workplace, both in my region and on the national level.

In the BC Region, Sister Sam Wiese (BC Regional Council Health & Safety Coordinator), Brother James Little (PSAC Regional Representation for OH&S) and I undertook a web-video series on health & safety issues. Our hope is that with these videos posted on the PSAC BC Regional website they will encourage members to get more involved with the BC Regional Union Safety and Health (BRUSH) Committee and take a heightened interest in OH&S issues.

This fall I also attended the Canadian Centre for Occupational Health and Safety (CCOHS) Forum IV "Better Together" in Halifax. Some of the issues discussed at the Forum included mental health in the workplace and workplace harassment and bullying, two areas of focus that have been of heightened focus recently. I'm confident that the information and resources I gained at the Forum will aid the preparations for the National Health & Safety conference that are already underway: these topics are also being incorporated within the agenda for the PSAC national conference, scheduled for delivery in Montreal in April 2013.

#### **Education**

The Education Program in BC is now in the final phase of the current three-year cycle. As always, the BC Region continues to expand the variety of course offerings: in May we offered a new one-day course, "Representing Members with Mental Illness" with much success; and in early December we will be offering the revamped 2.5-day "Advance Duty to Accommodate" course. Another new course that received a lot of positive feedback was "Women Reaching High," a course offered to women activists in the Southern Interior. This course will continue

the momentum of building real equity in our Union through the strategies developed to advance women's issues and improve our Union. It is our hope that similar courses can be offered in other areas of the BC Region in the future.

Throughout this fall and winter, 17 courses will be offered. In addition to the Region's education offerings, Leadership Training is taking place nationally in late November, and we look forward to incorporating that training into other areas of our education program.

We are also in the beginning stages of planning for our next three-year cycle and are looking at ways to seek input from all concerned to ensure that we continue the strong, enthusiastic education program that BC is known for.

#### **WFA Training Sessions**

We continue to offer WFA training sessions for members across the BC Region. These sessions are valuable for members for a variety of reasons beyond WFA education: members have commented that they really appreciated the in-person session and seeing the Union in their workplaces. In addition, the sessions provide us with another opportunity to speak about the We Are All Affected campaign and how they can contribute to the campaign.

Our Region will continue to provide this training for as many members and Local activists as possible throughout the Region that have, or will be, impacted by the federal job cuts.

#### **Equity**

#### **Regional Human Rights Committees**

The three Human Rights Committees in BC enthusiastically continue their work, and plan to hold a joint conference call to discuss regional issues.

#### **National Human Rights Committee**

As many of you are aware, in 2008 the PSAC commissioned the Labour Education Centre (LEC) to conduct a review of the EOC as mandated by the NBoD. This review was comprised of an assessment of the effectiveness of, and challenges faced by, the EOC. Also included in this review was an opportunity for re-imagining alternate structure or strategies in advancing the human rights agenda.

The result has been restructuring of the EOC into the National Human Rights Committee (NHRC) that aims to be proactive, coordinated and directly connected to existing Regional and Component Structures, including each Regions' Regional Council. Through this review process, women have also been reconstituted as an equity group with this other four existing equity groups: Members With Disabilities, Pride, Racially Visible and Aboriginal. One of the

other conclusions of the review was the recommendation that the NHRC hold at least one face-to-face meeting per year in conjunction with Committee conference calls.

The next NHRC meeting is scheduled in Ottawa for December 3-5, 2012, which will include participation by our BC Regional Council equity coordinators. The aim of this meeting is to allow committee members to understand the changes resulting LEC review and the recommendations for the re-visioning of the NHRC. Also included in the meeting agenda is a discussion around the decision to hold joint equity conferences in Toronto in November 2013 and the planning thereof.

#### Regional

#### **Regional Office Renovations**

Renovations to the Vancouver RO are for the most part complete. Our two boardrooms have recently been equipped with much-need A/V equipment that will better allow members to utilize the space. One of the last outstanding items on the renovations list was recently completed with PSAC signage installed on the exterior of the Vancouver Regional Office. Minor contractor deficiencies still outstanding will be addressed in the coming weeks (paint touch ups, mounting doors, etc.) which will finally conclude this renovation. I'd like to extend my thanks to the staff and members for their patience throughout this process.

While we had planned to host an open house this summer to cap off our office renovations, we thought it would be more appropriate to wait until a later date and focus our attention on the 'We Are All Affected' campaign and activities for the present.

#### **Regional Coordinator Competition**

This summer, Regional Coordinator Joanna Schultz announced that she had decided to pursue a personal business venture and leave her position at the PSAC after over twenty years of service with the Union. While we support Joanna is this difficult decision, we were saddened by her departure and felt the loss of her within the Region.

In her absence, and while a competition was underway to fill the vacancy, Garry Fraser agreed to step in as the Acting Regional Coordinator. Garry's experience and knowledge helped ease the loss of Joanna and allowed for a smooth transition between Joanna and the successful candidate.

While the competition is now complete, at the time of this writing announcements are still forthcoming as to who will assume this role in the Region. However, I am confident that this process allowed us to identify a candidate that will serve the Union as effectively and as passionately as our former Regional Coordinators have.

Please join me in welcoming the next Regional Coordinator and in extending our thanks to both Joanna and Garry for their hard work and commitment while in the role.

#### **Regional Convention Planning**

Planning is already underway for the 2014 BC Regional Convention. In July, Gaelle Felix flew to Vancouver to assist us with site tours of some potential venues in the Metro Vancouver area. Already we have narrowed the two options to two Vancouver hotels and we are in the final stages of proposal and concession negotiations that will allow us to finalize on one site. While at the time of writing this report we have not selected a site yet, we anticipate that our venue will be secured in early November.

Once the venue has been secured, I looked forward to working with the Regional Council's Convention Committee. Going forward, the Convention Committee will be working collaboratively with the PSAC staff and REVP to plan the Convention's program, agenda and theme over the year and a half. I anticipate that the Committee's involvement will greatly benefit and enhance the experience for all delegates at the BC Regional Convention.

#### National

#### **AEC & NBoD**

It has been a busy fall with several AEC and NBoD meetings in Ottawa, including strategy sessions for the both the NBoD and the AEC. These meetings and strategy sessions will allow us to identify and direct the priorities for the new three-year cycle that begins this January.

As you know, we have decided to renew the "We Are All Affected" campaign in the next cycle. Our hope is that this campaign will enable us to continue our work toward defeating the Harper Government. Funding for this next phase in the campaign will become available in January and will follow a similar direction as the 2012 summer outreach activities we undertook throughout the Region.

In closing, I would like to take this opportunity to note that despite the devastating job cuts and large number of affected letters that have been received over the last eight months, our Region remains active and tenacious in our efforts to resist and fight against the Harper Government and in defending the quality public services that all Canadians deserve.

As REVP for BC, I will continue to ensure that our collective voice is heard as we move ahead into the new three-year cycle, both for the BC Region and for the PSAC nationally.

# Good Jobs for a Green Future - Green Jobs BC Conference Sept 21 and 22, 2012

#### Goals:

- Advance policy initiatives that result in greater investment in and public support for green and community sustaining jobs
- Foster learning opportunities or discussion forums between labour and environmental organizations
- identify and evaluate opportunities to work with other sectors

Green Jobs BC exists to strengthen communication and cooperation between labour & environmental organizations. The Columbia Institute, houses the organization and moderated the event. The Green Jobs plan will be launched later in the fall. There were approximately 200 participants from labour unions, academia, government and business.

After a welcome by Doris Fox of the Musqueam First nations, the conference opened with a plenary featuring Jim Sinclair - BC Fed, Marc Lee - CCPA, Carla Lipsig-Mumme - Work in a Warming World and Tamara Vrooman - Vancity

**Carla Lipsig-Mumme** spoke about international research projects. Components of green jobs: new green jobs and greening the work itself. How we work can be transformed by adapting the labour process? For unions the benefits: bargaining climate issues, new stimulation for union members (youth) and good for adapting work. We must educate and mobilize the young.

**Tamara Vrooman** spoke about Vancity's experience with green jobs. Exploration around no trade offs, does not disconnect us with the community & environment. They made a decision to be carbon neutral - employee transportation was their biggest foot print. So they tried to hire staff within 5 km of where they lived. This was win-win. There needs to be a good dialogue with unions & employers about what green jobs look like.

Marc Lee spoke about what BC could look like in 2040 and how if started in 2012, we could reach a point where there is no longer reliance on fossil fuels. He really supports the implementation of a carbon tax, which could fund public transit hubs, education and shift funds to those with lower and moderately incomes. The biggest problem is money, the carbon tax has raise \$2.6B. It must be implemented to raise funds. It must be embraced in totality to build the support. We must engage the youth & diversity of this Province.

Jim Sinclair spoke about the crisis of the planet. We need to face it head on and huge powers against this crisis. The first crisis is the environment, the second is economic. The labour & environmental movement have to come together. We must find common ground where our children can have a clean environment and decent jobs. We want a world based on social justice, equality in the world. We need a large group a people to make the change. They have to create the will to do that. We have to have the hearts & minds of people.

Following was a series of concurrent case studies, of which, participants could choose 2 of 9. I chose the following:

Shifting the Way Business is Done - Creating empowering green jobs using the worker cooperative model. Shift Urban Cargo Delivery uses electric assisted cargo trikes that can transport 1.55 square meters of goods weighing up to 250 kg. They transport goods in downtown Vancouver that eliminates truck trips. They have applied a worker co-operative model to launch & grow the social enterprise and create green jobs. They are focused on regular scheduled deliveries for any product. They use the bike lanes & park on sidewalks. They also offer advertising on sides of trikes. B-line in Portland had a similar business model which they followed. In their first year over 14,550 deliveries, two full time trikes on the road and eliminated over 8000 kg of CO2. They are a for profit business co-op, where the workers are the owners. Each member employee purchases shares and had a profit of \$106,000 in the first year. They expect to break even next year with 4 full time trikes. The wage policy - they aim to pay a living wage, but are unable due to the financial risk. They are able to come to a consensus on wages. They want to transform the industry by replicating their model in other Canadian cities.

Good Green Garden Jobs School farms in Vancouver - partnership with "Fresh Fruits" and the Vancouver School Board - two 1/3 acre farms in secondary schools - Van Tech & David Thompson. There is only one elementary school now with a full partnership. They want to start & enhance food gardens. At least 60 of 109 schools have food gardens. Food will become more of a crisis because of global warming, etc. It is essential that people get the experience of growing some kind of food. They want to try to have food go into school board programs. Parents and teachers steward some gardens now. They are not funded by the VSB. "Fresh fruits" will bring in farmers & pack veggie boxes for Vancouver families. They want to have more farm to school programs growing in VSB. Some produce used in school programs, but there is still lots of room to grow.

#### **Evening Keynote Speaker:**

**Annabella Rosemberg** - policy officer on Environment and Occupational Health & Safety, International Trade Union Confederation.

On Aug 22, we exhaust nature's budget for the year. Sometimes communities consume more because they cannot afford other alternatives. 2.6 billion people have no adequate sanitation (40%), 3 billion have no clean drinking water (50%). The inequality gap is widening. 51/73 countries wages in total income has declined in the past 20 years. The risk of social unrest has increased. For example in Indonesia 3% of the GDP was lost due to flooding, including thousands of jobs. Green jobs are about employment, social protection and can reduce the environmental impact. Just transitions - a union proposal - make green opportunities real - a seed for systemic change, research impacts, collective bargaining & tri partisan alliances, training/skills, social protection, regional/local planning & workplace action/rights. We need to sustain the moments of change. We need to gain rights to challenge employers - such as right

to disclosure, empowering members, right to reorganize. For example, we need to challenge car ownership. We have variety of ways to move - balancing the way we move. We need to get stronger regulations to promote innovation - so companies will risk going green. Challenges - timing, territorial, intersectoral solidarity, balance of power. We are not organizing enough. Can/Will we integrate long term interest when we know short term decisions are going in the wrong direction? The majority of the world is not engage in something that is not of immediate benefit. What are the alternatives? Don't wait for someone to come with a sustainable choice for us. We need to anticipate change. If we don't inspire communities & show they are part of the future, then we will not succeed in a beautiful future that was envisioned (this morning by Marc Lee from the CCPA).

#### Sept 22

The day started with a plenary with Charles Campbell - United Steelworkers, The role of Public Policy in Green Job Development. He discussed partnerships between unions and environmental groups. This includes Blue Green Canada - to obtain commitment to use unionized Canadian made steel from renewable sources. The Steelworkers continue to fight for sustainable forestry, energy and other green initatives in BC. They have also reached out for a more sustainable renewable energy strategy, especially in Ontario.

The group then divided into Policy Development session; Energy, Forestry, Transportation, Service Sector and Building & Retrofits. The goal was to explore the policy recommendations that GreenJobs BC had developed, share feedback & discuss next step. I participated in Energy. The goal was not to come to consensus, but discuss, share additions/ommission and obtain ideas on the policy recommendations. New growth in natural gas consumption is industry (oil, mining), who pay half of what commercial & residential customers pay. There is not a lot of incentive for reduction in this industry because it is subsidized. There is a global trend towards the development of renewable energy. We need to attract that money to create jobs. This year, more money was spent on the development of renewable energy jobs then gas & oil. Many of these jobs are in China & Germany. Recommendations of the group included setting specific targets & timelines, bringing BC Hydro into the process, having middle & big picture targets, including more education & marketing, broadening engagement, building a business case and holding the government accountable.

We then split into seven different workshops. I attended the two following:

#### **The State of BC's Green Economy - presenters by GLOBE advisors**

BC is ranked 1st in Energy & buildings, transportation & innovation in Canada. The West Coast has the potention to produce many green jobs. Clean economy jobs lost less than other sectors on the coast. There is an increase in demand for electricity in BC. BC Powersmart has increase jobs by approx 6000 per year. Clean energy technology is being deployed across BC - using local resources to create energy. There has been a rise in carbon neutral communities. There are

growing export market opportunities such as biofuel and energy storage devices. Rising fuel costs drive efficiencies in transit. There is a trend in car/bike share program as urban density increases. We are adopting hybrids double other Provinces. BC is set to lead Canada in the roll out of electric vehicles. Increased focus on regenerative design in buildings. New technologies require new skills. Increase demand for energy & resouce efficient green building products. The largest employment opportunties are in reseach & innovation, engineering services, computer science & IT, professional support services and technical operations & services.

#### **Collective Agreement Language for Green Initiatives**

Many of the members won't put priority on environmental issues. Plus, we have to convince employers. Lately, employers have been asking for efficiencies in the agreement and members prefer money in their pocket rather than towards environmental issues. We shouldn't have to give something up to get this, but employers may not agree with this. CUPE & NUPGE has a booklet about bargaining language for their own employees and agreements, for example, a greater allowance for hybrid vehicles. There was a sharing between unions about what environmental changes have been made in worksites. Many unions talk about the environment throught OSH committees. The formation of committees may also help attract younger members. BC Hydro green team audit at worksite - they gave stickers & advice on saving energy. We want co-operative gains.

Overall, I thought it was a good conference. It could have been more participatory, but speakers were good & very interested. I liked the young entrepeneurs present who had great ideas and were building small business in this new exciting sector.

# BC Federation of Labour Report – Thompson Okanagan Regional Conference May 25 & 26, 2012 in Kelowna, BC

Thank you for supporting and giving me the opportunity to attend the BC Federation of Labour Thompson Okanagan Regional Conference.

The theme of the conference was "The Union Makes Us Strong" and the focus of the conference was on Visioning our Future; The Growing Voice of Labour, Increasing Union activism and Building an Action Plan.

The Conference was chaired by Sister Carole Gordon, President of the North Okanagan Labour Council and the NDP candidate for the Westside Kelowna riding and brother Ken Robinson, president of the Hospital Employees Union (HEU).

The conference was opened with the traditional aboriginal welcome and an address by Jim Sinclair; President of the BC Federation of Labour. Jim talked about getting back to the basics and the need for taking our solidarity and ethics out of our worksites and bringing them out into our communities. Bruce Nelson, a UBC Okanagan Graduate of Studies, addressed the conference on the future for the Okanagan Thompson region and Labour Rights.

We heard three different panel discussions:

- 1) Growing the voice of Labour, Building the community
- 2) We are the Union increasing member activism and
- 3) Political Action, Why the ballot box matters to working people.

Panel presenters for Growing the Voice of Labour, Building Community were:

**Michael McCarthy Flynn** – Michael has a Masters Degree in Community Development and has worked for a decade on a variety of antipoverty and social inclusion programs. Since 2009 Michael has been in Vancouver working on and organizing the Living Wage for Families Campaign. Michael provided an overview of the Living wage campaign and what they hope to accomplish with this campaign. One of the captions used in the campaign is "Work should lift you out of poverty, not keep you there."

**Karl Wolfe** – Karl is a member of the BC Government & Services Union and has been a union activist for years. He spoke about the power of community outreach. Karl is currently campaigning to stop the privatization of the BC Liquor Distribution Centre's and he highlighted the successful community coalition that he helped to coordinate to fight the privatization of the Coquihalia.

**Lucy Luna** – Lucy, a member of UFCWA, spoke about the struggles temporary and migrant workers face on a daily basis while performing their jobs. Lucy works on behalf

of both domestic and migrant agricultural workers in Canada. She spoke about the challenges workers face when they want to unionize, or to be covered fairly under health and safety laws, and the right of migrant workers to be treated equitably under the federal EI system. Lucy gave a very passitionate and emotional plea for everyone to help them fight their battles with unfair labour practices and for everyone to stand up and fight for the Canada of their dreams and for all workers.

Panel presenters for "We are the Union – Increasing Member Activism":

**Deborah Bourque** – Deborah is a member and long time activist of the Hospital employees Union. She spoke about how to increase member activism and about how the members of her union are faced with contract flipping regularly. She indicated that every time this happens they loose activists.

**David Westmacott** – David is the Executive Director of the Okanagan College Student's Union. He spoke about the struggles trade students have and their feeling of disconnect from the rest of the student body. David believes that cooperation between the student movement and the labour movement is essential to advancing progressive policies in Canada.

Kassandra Cordero - Kassandra is the Director of Young Workers for the BC Federation of Labour. She spoke about engaging young workers and to ask a young worker to participate as all young workers like to do things and participate. Kassandra highlighted some of the successful campaigns that the young workers have engaged in; the \$10 Now Campaign, Grant's Law and their continued battle with the recent amendments to this law and the new Employee Action & Rights Network (EARN). Kassandra showed a couple of video clips from the local news station showcasing their efforts and lobbying for the Grant's Law and the Bad Boss Award they presented to a local employer.

I was unable to attend the panel presentation on Political Action: Why the Ballot Box Matters to working People. Speakers for this panel were:

**Summer McFadyen** – Summer serves as the Director of Political Action at the B.C. Federation of Labour. In addition to her ongoing work for motivating union members to engage at the ballot box, Summer also represents the Federation on the BC Health Coalition Steering committee and serves on the Executive of the BC NDP.

**Scott Lunny** – Scott is the Assistant to the Director for District 3 of the United Steelworkers. In addition to being a key member of the union's bargaining committee in the BC Forest Industry, Scott has worked to spearhead the union's political action and organizing programs.

**Lynn Bueckert** – Lynn is the Director of Research, Campaigns & Communications with the BC Government and Services Employees Union. Lynn is also the Vice President of the BC NDP. Prior to joining the BCGEU she was the Executive Director and Director of Occupational Health and Safety of the BC Federation of Labour.

#### Additional Guest speakers were:

Mohini Singh, Councilor, City of Kelowna. Mohini is a community activist; she has participated in a wide range of activities, many helping those who are disadvantaged or building bridges within and between communities. She has advocated for women and children who have experienced violence and has promoted cultural tolerance and understanding. She has worked on issues as diverse as avalanche safety, spousal abuse, literacy and the plight of orphans in India.

Both Adrian Dix, Leader of the BC NDP and Jinny Sims, NDP MP for the Newton-North Delta riding in BC addressed the conference.

Throughout the conference we broke plenary and attended workshops.

- 1) Visioning our Future Labour in the Thompson Okanagan
- 2) Labour in the Community
- 3) Strategies to Increase Member Activism
- 4) Working People Vote; Building Our Action Plan

For the workshops, participants were divided into their electoral ridings. I felt that the time spent in our workshop was unproductive and very unorganized, however, during the workshop we determined what we wanted to achieve in our community, why we want to achieve this for our community, who we need to involve to reach our goal and who are our allies. My group's action plan is to work on changing the government. We need a government that will work with unions and for the people. Although our group came up with many things we would like to achieve for our community; our first and primary goal is to elect an NDP MLA and from there build on electing an NDP MP. We have a lot of work to do in our community.

During one lunch period we joined members from the BCGEU for a rally on behalf of Seniors and Spring Valley Health Care Workers. BCGEU members were protesting the contracting out of Seniors Health Care Services. The passage of Bill 29, allowed care facilities to contract out care and support services to reduce wages. The Supreme Court of Canada struck down key parts of Bill 29, but it did not restore contracting out protections to health care workers. BCGEU members believe this is one more example

of how Liberal policies have failed seniors and their families. At the same time it continues to drive down wages of health care workers, most of whom are women. This rally was held outside the office of Liberal MLA Steve Thomson. The rally had very good television and newspaper coverage.

On the Thursday evening we were treated to a wonderful reception at the one and only unionized wineries in the valley, Mission Hill Estate Winery. We enjoyed the awesome views from the spectacular grounds, toured the cellars and were treated to appetizers and glasses of red and white wine.

Again, I want to thank you for allowing me the opportunity to connect with members of my local District Labour Council and the union activists in my region.

Susan Yaciw Kelowna Local 20003 PSAC Regional Coordinator for Southern Interior - Martha Johnson Report to the BC Regional Council

Since the Committee ratified the decision for me to take over the role vacated by Keith Palmer, my activities have been as follows:

- Sent an email to constituents introducing myself as newest member on Council. Advised which sub-committees I have been assigned to as well as my role on Okanagan Area Council and Women's committee. Urged members to contact me about workplace issues and community events that would make good venues to promote the Labour movement.
- Sent an email to chairs of respective sub-committees to touch base and enquire about work-in-progress or action items left outstanding upon Keith's resignation.
- Met with Susan Yaciw to discuss role as Coordinator and plan outreach to Kootenay and area. Reviewed success of Area Council road trip through Kootenays in 2010 and discussed possibility of doing this again next summer (2013)
- Received visit from REVP at Penticton Veterans Affairs Office. Gave Bob the office tour and he was well received by the membership as well as the Area Director.
- Accompanied REVP on site visits in Penticton. Depts/Agencies visited were: Veterans
  Affairs Canada, CRA, Service Canada and Measurement Canada. Discussed impacts of
  Budget 2012 in respective sites and canvassed members about their specific issues and
  area council involvement.
- Provided support to Women Reaching High Retreat, Naramata as member of host committee, Sept 13th – 15th. I cooked incredible burgers for incredible women!!
- Susan and I prepared a pamphlet describing role of Area Councils and Regional Council which included contact information for all Council Members. This info was delivered to the Women Reaching High participants as our contribution to the Day of Action Events on Sept 15th.

#### **Challenges:**

Assuming the role of Council Member so far into the year put me at a handicap for planning attendance at community events. As a result, my contribution to sub-committee work pretty much started and ended with my email to the chairs. By the time I got into my research, most events were booked or over. I hope to contribute something of value to each committee in the future. Not sure what that will look like.

As a result of Budget 2012, I received an affected letter on April 11 along with 252 of my Client Service Agent peers at Veterans Affairs Canada. Members were made to go through a full blown competition process for the SERLO (selection for retention or layoff). We lost 75 members during that process. Sadly, some members disregarded union advice and simply volunteered to retire rather than face a competition. In doing so, they essentially gave the employer a gift as they did not receive WFA options. Final notifications went out July 19th. In my office, 2 were WFA'd. In early August, the BC Interior was amalgamated with the Vancouver District who lost their local President, Secretary and Treasurer. Between July 19 to present I have spent a great deal of my time mentoring the Vice President and prepared 4 staffing tribunal complaints during that period as well. One complaint was subsequently dismissed as untimely and 3 others were voluntarily withdrawn by the complainants.

The VAC ADM has since announced that Senior Management is embarking on an "aggressive workforce management initiative" in the coming months. FTE reductions are targeted at 804. So far, just over 200 jobs have been eliminated – the worst is yet to come.

We are finding that the emotional fallout from the process has been immense and staff are still reeling from the impacts. Client service agents in some areas are handling caseloads more than double the standard as we have absorbed all the work from positions we supposedly no longer need. The employer didn't bargain on most wfa'd staff leaving their jobs immediately and now the backlog of work is huge. As a result, Senior management has deemed that "meaningful work" to be done by the few CSA's who have selected Option A, will indeed be CSA work. This is adding to the stress in the workplace and the union has advised that the employer can get away with this as there is no legal description of what constitutes "meaningful work" under the WFA policy.

The impact on our Veteran clients is also appalling as they are being abandoned by the Department when they need us the most. Meanwhile, Harper and Blaney have smilingly assured Canadians that Veterans will see less red tape and now have over 600 service locations across Canada. Sadly, this is far from the truth.

In fact, what follows is an example from a co-worker and shop steward: Recently a 92 year old Veteran client attended the Service Canada Office in Kelowna where our VAC office is co-housed. The Veteran stood in line with his walker for 40minutes to be told be Service Canada that he can no longer access the VAC staff in the same building. He was led to a computer terminal and given brief instructions on how to apply for benefits. At 92 years old, it's no surprise that this gentleman wasn't able to comprehend what the agent was telling him and requested that she assist him. She apologized and advised the client that she is not authorized to assist in this manner. This War Veteran then returned to his vehicle and made the lengthy commute back to his home where he called the toll free number and started his enquiry all over again. How appalling that our War Veterans and our elderly are being treated so poorly.

PSAC Regional Coordinator for Northeast BC - Patt Holmes

Report to the BC Regional Council

Our Prince George Immigration office has closed! There is one member left at Veteran's Affairs! I have heard 12-15 members at CRA/UTE have been affected by Workforce Adjustment measures. Do you know we have lost our Agriculture Farm, UNDE Local, Department of Indian Affairs and other Northern Federal offices/services have shut down?

#### Service Canada:

We have gone from five departments that will soon be reduced to only two. There will be front end staff and Integrity staff left. Ther ewill be front end staff and Integrity staff left. In repect of those who have left or are being workforce adjusted, the members want others to know that they are not just numbers to be "muttered." There are names attached to each person being workforce adjusted. All of us are affected ... Our membership at Service Canada used to be 110, and it will be reduced to what I believe will be less than 45 members.

We use to have three separate unions in our office: CEIU, UVAE and PIPS. There will only be CEIU members in our building in the future. Will we relocate to a smaller office? Or be gone?

Since the last Vancouver Regional Council meeting, I have participated or being invited to a number of events. I did my best to attend as many of the Regional and Union functions as time permitted.



PSAC Members With Disabilities Equity Coordinator - Tracy Shudo Report to the BC Regional Council

Since the March Regional Council meeting, the biggest issue I have been involved with has been our ongoing campaign, "WE ALL ARE AFFECTED." I have strong feelings about this campaign and our responsibility to act as Regional Council members. This summer, we needed to get involved in the campaign, seek member participation and support so that we could inform all our members and general population on the impact of the federal spending cuts.

One of the first activities that I participated in involved working with another Regional Council member: Jennifer Ho and I attended three different committee meetings to ask for their involvement with summer activities and for financial support. All three of our meetings went over very well.

The first meeting we attended was the West Fraser Valley Area Council meeting. At this meeting, we discussed how the new campaign would work and provided guidance on how to run functions and activities in the area. We emphasized that we would need member support and finical support from this committee to proceed. The feedback from the Area Council was very positive, and we were given a large financial contribution to help fund the Surrey Pride Festival booth and the 2-day booth at the Surrey Fusion Festival. It was empowering to see how involved people got just by being asked to help.

Our second meeting was the Regional Women's Committee AGM. As with the West Fraser Valley Area Council, we told the committee members about our plans for summer activities and that we needed their involvement and financial assistance.

The final meeting was with the Vancouver Human Rights Committee. We explained that the Regional Council needed members' support for the Vancouver Pride Festival as well as financial support for the Surrey Fusion Festival. I am proud to say we received overwhelming member and financial support from this committee.

#### **Summer Activities and Functions**

Over the course of the summer, I transported equipment to the campaign events and volunteered at the booths for five days. This included participation at the Protein for People action, the Surrey Pride Festival, the Surrey Fusion Festival and the Vancouver Pride event. At all of these events, it was very easy to get people to sign our petitions when they

stopped by our booths.

At Vancouver Pride, there was a strong contingent of young people that came to our booth. Many of them were seeking the highly-coveted "Stephen Harper Hates Me" buttons. I took that opportunity to ask many of them if they had voted in the last election given their feelings toward Harper and his Government. Many advised that they had voted (but not for Harper), while the rest indicated that they would be casting ballots next time. Again, I strongly believe we just have to get the message out to people and they will come out to vote during the next election.

#### National Day of Action - September 15th

I was happy to attend the September 15th National Day of Action event in Vancouver, which took place on Commercial Drive. We had great speakers and there was a large board available to write about what impact the cuts have had on you personally.

At that September 15th event, I learned that an Occupation of the Kitsilano Coast Guard Station was underway by members of the PSAC, UCTE, BC Fed and other stakeholders. At the Commercial Drive event, members were encouraged to go to the station at 5:00 pm that evening to greet the occupiers as they vacated the station. We were given the opportunity to cheer them on and encourage what they had done. The intent of our presence at the Station was to emphasize the statement made by the Occupiers in their Occupation. I was able to go to the Station that evening. I can attest that there were several members and media in attendance along with lots of cheering and support.

#### **Members With Disabilities Equity Portfolio**

I have been very active in my position on BC Regional Council: I attended the Vancouver Island Human Rights AGM on Sept. 13, 2012 and was happy to see new members in attendance. Not only did some of these new faces join the committee, but a few of them also took seats on the Committee's Executive.

I also attended the Vancouver mainland Human Rights Committee AGM. At the AGM I ran for re-election to the Chair position and was privileged enough to receive the title for a second year. I am very honoured to hold this position, and my goal is to have more and more people learn about this committee and to join us.

During the summer months I also attended two NDP campaign fundraising dinners. At these dinners, I had the opportunity to hear about the different initiatives and actions the

NDP is undertaking from members of the NDP. With this information, I am more convinced than ever that Mr. Adrian Dix should be the next leader of our province. I will do all I can to support Mr. Dix and the NDP so that this comes to fruition.

Thank you all for reading this report. It is the first time I've written my report in this format, rather than listing dates and activities that I've attended. While it was a struggle to write in this new format, I feel that it better shows how I feel about the work I am doing for our Union.

Report to the BC Regional Council

Trying to pull together a report and came to the realization that I really haven't done a lot over the last 6 months, but have managed to be busier than ever.

We have held two very successful and informative BRUSH meetings since our February Conference. I am currently updating our Terms of Reference to reflect suggestions of conference participants. The update will be presented at our next BRUSH meeting and I expect it will be adopted. The only major change is increasing the number on meetings from four to six per year.

September 15 National Day of Action I had fun and am sure the others who attended had fun as well. It sure would have been nice to get more members out. I see that as our biggest hurdle, one that is not unique to the PSAC but to the Labour Movement en masse. Members expect good collective agreements, which ensure a measure of job security, decent wages, safe working conditions wherein they are free from harassment and bullying, yet they are not very willing to take action to show support. While we didn't get the numbers out to Granville Park on September 15, I sure did get a lot of "what is PSAC doing spending our dues like that?" over the "Stephen Harper Nous Deteste.ca" banner. My standard reply is that it obviously worked, people are talking about it...and it got your attention...

On the political front, I have once again had the opportunity to work with forward thinking people in Spokane and Bellingham in a push to get the Obama vote out. I did phone banks in Spokane on October 27, Bellingham on November 3 and am planning on getting to the Mount Vernon phone bank on the weekend of November 10.

I attended the October 10 Town Hall meeting in Burnaby, Burnaby Residents Opposed to Kinder Morgan Expansion (BROKE). It was a lively meeting and I think the following statement from Mayor Derek Corrigan sums up the 'mood' quite nicely:

"The Federal Government determines what's in the National Interest, and if they determine it's in the National Interest—that is, what's in the interest of Alberta—they can proceed with pushing through a pipeline through our community no matter what kind of bylaw the City of Burnaby proposes."

PSAC National Officers Coordinator - Nic Humphreys

Report to the BC Regional Council

A National Officers meeting was held March 2nd, 2012 at Sheraton Hotel in Richmond. There were 17 national officers in attendance, 5 staff (in and out during meeting), 2 guests and 1 observer. The meeting took place the day prior to the PSAC Convention Delegate meeting, which pertained to resolutions going forward to the PSAC National Triennial Convention.

The agenda was a full with lots of discussion, some of the main points of discussion were:

- The recognition that the BC region was the only region that had a national officer coordinator position on the regional council and was also the only region that held a pre-convention meeting of PSAC delegates.
- REVP Bob Jackson provided a report on the Region's activities on the March 1st Day of Action, advising that BC was hugely successful in its efforts, producing over 300 photos displaying our efforts and solidarity. Bob also asked that each National Officers pass on his thanks to their Components for their roles in the effort. This event was not just a PSAC event, but instead a commitment made by all Components to act in unison.
- Nic Humphreys canvassed the National Officers present, requesting them to identify their top priority resolutions. There was a consensus from the majority of officers present that without the draft committee reports, commenting on their resolution priorities felt a bit premature. However, there were some officers prepared to speak on their priorities and did so. To alleviate some of the concerns voiced on the lack on information before the National Officers at this meeting, the Convention Committee members present provided some context for the draft priority resolutions for their respective committees.
- Nic Humphreys then opened discussion on campaigns and issues. He asked that the
  Officers provide reports on the same for their Components, 14 national officers talked
  about and promoted various campaigns and issues that were currently important to
  their components.
- Regional Representative Monica Urrutia provided an update on the WFA activities and elaborated on the resources available from the Regional Office, including three different options for training members, lunch session, half day or full day session. Monica listed the tools available for WFA training, Trends and Themes within WFA training and then Monica then took questions.

- Bob Jackson introduced Brother Jim Sinclair BC Federation of Labour President to the National Officers and gave him the floor to address the current labour landscape in BC, speaking specifically on the Provincial Government's budget, cuts to public services along with the current BCTF situation and the proposed Bill 22 legislation. Sinclair called on Labour to take action to change the current climate: to get smarter politically and change the system, noting the political struggle is not just at the ballot box but also at the bargaining table. This creates a common front for Labour to take action, especially with regard to Bill 22. He also commented on the upcoming bi-elections in Port Moody and Hope-Chilliwack, suggestion that we need to send a message to the BC Liberals through these votes, and to more specifically communicate what this vote is about.
- Brother Tom Hopkins was invited to provide an update on TC group bargaining. He advised that they will be back in bargaining next week and that they had signed off on a few issues. Hopkins continued that bargaining won't likely conclude until September. Tom concluded by noting the hold up in bargaining will be the essential service agreements; these need to be in place first. Dave Jackson, Regional Representative, then took the floor to expand upon TC mobilization
- Discussion again turned to WFA in light of the anticipated job cuts. Nic Humphreys
  commented that UEW has taken advantage of the training resources being offered by
  the Regional Office. Nic commented that we have to be proactive and not wait for the
  WFA letters. He went on to suggest that we need to expand WFA committees to ensure
  that communication happens between Components so that they are aware of vacancies
  via alternation processes.
- Bob Kingston added that there is a federal Council forum in each province in BC it is the Pacific Council of Senior Federal Officials – that can be utilized for this purpose. This was the same forum that was used in the past to deal with layoffs. He further suggested that it would be prudent to make contact and ask to be put on the next meeting agenda to discuss WFA.

Discussion then turned briefly to potential severance packages included in the WFA appendices before the meeting concluded.

The next National Officers meeting will be held sometime in the spring possibly in conjunction with a Regional Council meeting.

Report to the BC Regional Council - September 2012

The Environment Committee exchange ideas and actions on a regular basis through email since the last Regional Council meeting. The Committee did an excellent job in adhering to the action plan that was developed at the last Regional Council meeting.

- Current environmental issues were provided on a more than monthly basis as were new environmental issues;
- While no Regional Council members or any PSAC members contacted the Committee with issues or campaigns that they would like promoted through the Environment Committee, we were prepared and willing to do so;
- The Environment Committee presented to the members of the Council a document that outlined the environmental problems originating from the gateway project and also provided information and numerous links on how to get involved politically;
- Terri Lee represented the Environment Committee, and actually the whole Regional Council, at the recent BC Federation of Labour sponsored "Green Jobs" conference. (Report included within Terri Lee's Coordinator report);
- The Committee continued to liaise with the BC Federation of Labour and BC labour councils around their environmental issues.

The Enbridge pipeline issue will be one of the big, if not the biggest, environmental issues for British Columbia at least until the provincial election and probably well into the future. As we expect that all of you will be involved politically in the next provincial election, we believe it would be beneficial to everyone to inform themselves as much as possible around the proposed Enbridge pipeline.
