#### **UPDATE FROM BC-REVP**

The following updates provided by PSAC BC REVP Jamey Mills:

Bargaining. Most units, with the exception of SV and CFIA, had called for strike votes when pandemic started. The CRA votes were almost finished. All votes are on hold. Bargaining teams are ready and available for further negotiations so if TBS calls, teams would return to the table. UPCE has negotiated a collective agreement with Canada Post, PSAC staff are available even though offices are closed. PSAC members are working at unprecedented levels including at CRA, EI, Customs, Food Inspection, postal, airports, etc. which is a testament to members dedication to keeping Canada running. **Conventions.** BC Regional, Component, CLC all postponed. A small committee has been struck at PSAC to determine how to proceed. Important business such as passing budgets and resolutions as well as election of REVP need to occur. Hope to have plan by May 1<sup>st</sup>.

Internal Organizing. Important to work on internal organizing capacity for COVID19 communications and ratification votes.

## Q&A

Is training on hold? PSAC currently looking at alternative delivery such as webinars. There was a recent Health and Safety webinar in BC and other topics will follow including mental health and ergonomics. Courses are being rolled out in geographic sequence due to limitation with webinar software. The training is also tailored for each jurisdiction considering the needs of Directly Chartered Locals and small employers as well as provincial standards. Comment that ergonomic webinar would be timely considering issues with working at home.

Are there any national campaigns to address public frustration? Yes, Still Here for Canada campaign – "PSAC members across the country are working hard to get Canadians the help they need during this pandemic, and to make sure all the services we depend on keep going. No matter what, we're still here for Canada. Let everyone know how your work is helping Canadians. Upload a photo using this form and tell us about your work. We'll be posting your stories on our national and regional social media accounts." Also working to have media attention - good article recently in National Post.

Please comment on the issue of public perception around bargaining during this unprecedented time. Important to get back to bargaining table as it is a time to be working together for all Canadians.
