Motion:

Moved that the Okanagan Regional Women's Committee authorize the expenditure of \$50.00 towards the program "Ouch, your silence hurts me!" an educational program consisting of 2 videos. The total cost is \$1100.00 and the program would be for all of the province. It is hoped that the cost would be shared amongst the 8 Area Councils and the 4 Women's Committees and the 3 Human Rights Committees...\$400.00 and request that the B C Regional Council contribute the remaining \$700.00.
