# Projects/Events

## Question:

"Keeping in mind our current COVID limitations..... What is one project/activity our Human Rights Committee might like to work on?"

### Response:

Group 1 – would like to revive/move forward with the waterbottles. It was felt that these could be used for promotional events and advertise human rights. Allow for a discussion about our group. Bottles could also be used for guest speakers, conference baskets and even possibly when we reactivate our building communities Blanket exercise project (post COVID)

Group 2 – Discussion about migrant workers and COVID. The groups idea was to reach out to this community in a safe manner during COVID. It seems that there is a fair size population in the Oliver area. After a lot of discussion it was agreed that we reach out to organizations like RAMA and suggest a joint venture. Committee was in agreement that we would have our next meeting in Oliver and look at possibly setting up a table with give aways – to draw workers in. Both Robert and Maria-Luiza are able to communicate in Spanish so this will be extremely helpful.

### Round Table

Robert – talked about the high uptake on webinars and encouraged us to get the work out. Kelly mentioned that Service Canada Okanagan front-ends were being allowed to take them on work time (including the right to refuse dangerous work which was a bit of a surprise). Robert also responded to questions on the BC convention – possibly spring 2021.

Linda- Stats Canada is starting to allow some minimal drops but no contact is still in place for the most part. Issues with working from home discussed.

Kelly – Has been participating in a lot of webinars. Recently attend the Anti-Racism CLC webinar as well as Amnesty, Right to Play, etc. Looking forward to attending the women in leadership webinars next week.
