Call to order 1:30

The committee met prior to our social event on September 10 2016 at the Rooftop bar/Volleyball.

The committee discussed the response to the call out for the event. We were anticipating approximately 15 attendees. Vanessa stated that she is hopeful that we will get some new interest coming out of the young worker conference in the fall as well. Vanessa stated that we have had a lot of interest in the conference and we are finding that in the last year we have seen increased numbers of self id's.

Brittany Forbes stated that she is continuing to work closely with Generation Squeeze heading into the provincial election. She stated that we would be hearing from Paul as well at the Young Workers Conference. Brittany and Vanessa gave a quick overview of the general these of the conference and what we be focusing on. Vanessa asked the committee if there was anything that they wished to highlight as a part of the history. The committee wanted to ensure that the story around the triennial convention and the resolution was a part of it.

Sarah asked if the conference would be in residence. Vanessa stated that it would not be. Vanessa stated that this does not prevent the group that would be attending from opening up their rooms in order to ensure that people from the lower mainland could stay. Vanessa indicated that we had requested for the conference to be in residence but that the final decision lays with the REVPs office and this had been decided to follow the PSAC travel policy. Vanessa confirmed that we had also heard from Carl Gagnon - President of UVAE and he would be attending as a guest speaker.
