Motion to accept Agenda moved by Virginia, seconded by Kay. All in favour.

Vanessa reviewed minutes. Virginia motioned to accept as read, Kay seconded. All in favour

Kay provided financial update. Vanessa Motion to accept. Virginia seconded. All in Favour

The committee discussed planning for 2016. There was discussion around typical events the committee supports including International women's day, and December 6th. Added to this there as discussion of the March in Vancouver on February 14 2016. There will be a similar walk on the island. March 7 and 8 there will be a press conference and rally for the BC Fed in Victoria. The Committee discussed a funding request to help fund CLC winter school for Patricia Martin. Discussion ensued around requested \$250. Further clarification was sought around other funding that had been requested and received and the breakdown of what the money was for. The Committee then discussed December 6 and purchases that were made for the organizations we support. Virginia stated lost some receipts. She stated that she will be submitting bank statements discussed items that were purchased for each of the organizations. It was noted that the cheque from Victoria labour council has not been received yet and Virginia would follow up at the next Labour Council Meeting.

Virginia reports back on BC Fed women's Committee. She indicated that Ontario just passed legislation with wording around domestic violence and how the employers can now be liable for not acting if they are aware or suspicious. It was noted that it was hoped that BC would follow suit.

There was further discussion around contract negotiations and the state of the federal government hiring. It was noted that Veterans Affairs is hiring as has Service Canada. We mentioned that CRA has been without contract for almost 4 years and TB tables akmost 2 years. looking at the PA group it was noted that there was a large amount of female staff. Discussion ensued around the impacts of contract negotiations on women specifically.

Lorna made a motion to cover the additional costs paid out by Virginia when shopping for the organizations in December. Kay seconded the motion. All in Favour.
